

The Alternative Methods of Dispute Resolution Committee of the State Bar of New Mexico conducted and accomplished the following in 2022:

- 1. Board of Directors
  - a. As a committee, the ADR Committee does not have a board of directors. There is an active steering committee of approximately 6 people.
  - b. 2022 steering committee members: Peter Merrill, Laura Bassein, Tamara Couture, Rachel Donovan, April McClellan and Brandon Ilgen.
  - c. The steering committee met in January, April, July, and October.
- 2. Committee Meetings
  - a. The regular committee meetings were held, January, April, and October.
- 3. Continuing Education Presentations
  - a. The ADR Institute was held on 11/30/22. The speakers and topics were, Maxine Chavez, Owner Abq Drug Testing, on Drug Testing and Chain of Custody. The second session speaker and topic was Lori Millet of Abq Elder Law on Capacity to Mediate. There were 54 total registrations for the presentations and there were 2 parties expressing interest in joining the committee. The event was attended by Judges, Attorneys, and


Mediators. As a result, the courts are making updated procedures for ordering of drug tests as needed by the court. There is also new information shared on the capacity status giving all participants the most current information to promote best practices for the legal community.

- 4. Committee Outreach/Initiatives/Events
  - a. The ADR Committee held a Lunch N Learn for the general bar membership on 10/28/22. The presentation was Lori Millet of Abq Elder Law doing her first presentation on the Capacity to Mediate. There were no CLE's offered. The ADR Committee reached out to several organizations outside of the state bar to offer the Lunch N Learn and had 82 register for it. Because of the large interest in this topic the steering committee decided to offer it again at the institute and give CLE credit for it.
- 5. Scholarships

  - a. Forward moving plans for 2023 are for Lunch N Learns every other month, in addition to networking with other ADR communities throughout New Mexico. 


The (section/committee name) conducted and accomplished the following in (year):

- 1. Board of Directors
  - a. Eric Sedillo Jeffries, Co-chair
  - b. Johnn Osborn, Co-chair
- 2. Meetings:

a. The co-chairs, Eric Jeffries, previously Fred Federici, and currently Johnn Osborn, usually plan annual presentations at the State Bar building, with buffet, to which members of the Historical Committee and all members of the New Mexico Bar, with guests, are invited. The pandemic reduced the typically popularly attended presentations to a few audience members and the rest of the audience, about 20 or so, attending by Zoom.

b. In 2020, due to the Pandemic, there was no typical Fall annual presentation, but there was a book review on Tom Chavez's book, *Spain and the American War of Independence*, presented in 2018, that addressed how Spain, through its Mississippi water highway avoided British blockades, and thereby largely financed our American rebellion against the then mutual enemy, Britain. Tom Chavez is the dean of New Mexico's historians. He was honored by Spain's King Carlos for his scholarly contributions to Spanish history. Tom presented in 2017 or 2018.

c. During the pandemic, we conducted a belated December 2020 presentation by Bar member and nationally recognized coin expert Rod Frechette entitled "Eight bits to Bitcoins, Trade and

Wealth 1556 to 1854." Since Spain and Spanish silver largely financed our American Revolution Rod's talk was very interesting despite numerous Zoom technical problems.

d. Last year, in the Fall of 2022, DC/NM attorney/historian, Henry Rivera, one of our best speakers, presented on the Mexican army's San Patricio Battalion, consisting of mostly Irish Americans, 76 of them deserters from the US Army during the Mexican American War. At the time, there was very strong U.S. prejudices against Irish immigrants and Catholics in general. Moreover, in the war years of 1846-1848 what defined being an "American" in our young nation was ambiguous. After some battle success the soldiers of the San Patricio Battalion were mostly captured and hung from public galleys, in full view of the fighting at Chapultepec. Mr. Rivera's presentation was very impressive and enthusiastically received.

a. Before the pandemic the State Bar Bulletin announced all our annual meetings. The turnout was usually enthusiastic. A presentation by Randi McGinn on Billy the Kid was among the successes.

b. Before the pandemic Bar members signed up for the Historical Committee on their Bar registration form just like any other Bar committee. Typically, 20 or so Bar members so registered. In addition to the annual meetings, we would have occasional lunch meetings with people of interest like Ray Sanchez when he was the House Speaker, Senator Dede Feldman, and former Governor David Cargo of Rio Arriba County Courthouse fame, a very amusing guest. The Bar only pays, if at all, for the meal of the luncheon guest.

c. We ask the Bar to again include us as a registration alternative, because we have no other effective way of efficiently knowing which Bar members love history. If we knew who to invite to the lunch, former House speaker Brian Egolf, or present Speaker Javier Martinez, could be our next guests.

8. Ongoing Section/Committee Items:

a. In 2023, despite the absence of the Bar's traditional support we would like to informally register at least ten (10) Historical Committee members.

b. We think our next presentation on or about March 10, 2023, by Henry Rivera, again with a declined honorarium, should qualify for one CLE general credit and, with the Bar Bulletin's help, should again attract a crowd. Mr. Rivera will present, with graphics and photos, why Jefferson Davis authorized the Confederate invasion of the New Mexico Territory. Legally, Mr. Rivera will address the Compromise of 1850, its impact on Jefferson Davis' thinking and its impact on Texas' claim to New Mexico. The talk


also touches on the 3/5<sup>th</sup> Clause of the Constitution, the Treaty of Guadalupe Hidalgo, the Wilmot Provisio and the Fugitive Slave Law.

c. Mr. Rivera has agreed to lead a tour for State Bar members of the Civil War Battlefield at Glorieta likely in May, 2023. The tour will begin with an orientation talk at El Rancho de Las Golondrinas followed by a day-long, detailed tour of the battlefield itself. Mr. Rivera will again decline an honorarium.

<u>Conclusion</u>: The Historical Committee of the New Mexico State Bar, due to Covid, has been in a weakening transition process for several years. While in the past there was greater participation, we are currently a committee of two. With the requested help from the Bar, we intend to regrow our membership, author historical articles for the Bar Bulletin, and establish CLE credit for at least some of our luncheon presentation. If you have suggested topics, we are listening. We intend to keep the historical stories of the New Mexican Bar alive and well for future generations. It may be news to you that the State Bar has a growing collection of recorded histories from New Mexico's retired lawyers.

We want our committee to return to the registered, Bar supported status it had before the pandemic. We would be honored to personally advocate our position to the Board of Bar Commissioners of the State Bar of New Mexico.

  - a. In 2022, the Committee held quarterly meetings, on January 7, 2022; April 1, 2022; July



The New Mexico Well-Being Committee begins its fourth full year with many accomplishments and ambitions.

Below is a brief summary of the committee's history, structure and accomplishments in 2022.

The Well-Being Committee was created prior to the beginning of the Covid 19 Pandemic in an effort to encourage health and well-being among New Mexico lawyers. This committee was also created with the intention of following the steps laid out by the National Task Force on Lawyer Well-Being. The NM Well-Being Committee is comprised of representatives from the bar, the law school, the Judiciary, and the paralegal community; all of its members have an interest in well-being.

Four subcommittees meet regularly to work on different aspects of well-being programming: Strategic Planning, Events/CLE, Yearly Campaign, and Judicial Wellness. The subcommittees met as needed between the larger Well-Being Committee meeting which met every other month.

There are several items to highlight for the BBC that the Well-Being Committee implemented and continued in 2022.

# • Yearly Campaign

This subcommittee focuses on developing annual campaigns which feature how self-care and legal profession can co-exist. Through each campaign, the podcast will enlist local leaders to speak on topics that integrate their personal life with their legal professional life and how they find meaning and purpose in both. All campaigns will feature the ways a legal professional can be a practitioner and a healthy human being.

#### • Judicial Wellness

This subcommittee is comprised of stakeholders throughout the NM judicial community. Led by retired Judge Sandra Engel it promotes and optimizes health and wellness among New Mexico Judges by creating and facilitating educational programs and offering resources and services which provide a supportive environment for our judiciary in order to restore and maintain ones overall mental, physical, and spiritual health. Highlights include a Judicial Coach Resource, monthly JWell Now e-blasts, educational well being presentations at judicial conferences, and a helpline for any judge or court staff struggling with any mental or emotional issue.

#### **Future Goals and Plans**

#### 2023 Well Being: A Deeper Dive

The Well-being Committee's goals in 2023 will be geared toward taking a closer look at well-being beyond the basic building blocks. Sharing how individuals can move from just getting by to thriving will be a primary goal of 2023. In addition, the Well-Being Committee will examine how best to inculcate those experiences into the legal community. The topics for the podcasts and articles so far include: an introductory to the campaign in January of 2023, and How to Thrive from the Inside Out in February.



- 2022 presentations:
  - Tracy Jenks: February 2022 -- Animal Talk with CLE presentation regarding Jenks' defense of a subrogation case involving property damage to a passenger car when the car struck and killed her client's pet dog who had escaped an enclosed yard and ran out into a busy street. In defending the case, Jenks raised the legal issue of whether a pet owner's liability for damages caused by the owner's pet arises in negligence or in strict liability.

 Maya Van Rossom, -- founder of Green Amendments for the Generations – January 2022.

"Green Amendments are self-executing provisions added to the bill of rights section of a constitution that recognize and protect the rights of all people regardless of race, ethnicity, religion or income, including future generations—to pure water, clean air, a stable climate and healthy environments."

"The amendment was first proposed by State Senator Bill Soules (D-Doña Ana), Senator Antoinette Sedillo Lopez (D-Bernalillo), Senator Harold Pope Jr. (D-Bernalillo) and Representative Joanne Ferrary (D-Doña Ana) during the 2021 legislative session. While the amendment passed out of the Senate Rules Committee with majority support, it didn't make it to a hearing in the Senate Judiciary Committee, so it failed to advance."

"Key senators are making the amendment a priority for the 2022 passage. The Joint Resolution for 2022 consideration proposes amending the New Mexico State Constitution's Bill of Rights to recognize and protect the rights of all of the people of New Mexico 'to a clean and healthy environment, including water, air, soil, flora, fauna, ecosystems and climate, and to the preservation of the natural, cultural, scenic and healthful qualities of the environment'; to ensure these rights are protected for present and future generations; and to designate all the state's government officials as trustees of the natural resources of the state constitutionally obligated to 'conserve, protect and maintain them'." *Unruh, GA; "The Paper"; 11/11/2021.* 

- Tammy Fiebelkorn April 2022: The Link Between Animal Abuse and Domestic Violence. Fiebelkorn is President of The Link New Mexico, an environmental and business consultant, and a member of the Albuquerque City Council. The virtual presentation did not attract enough attendees and the board members in attendance decided to convert the presentation to a podcast through the SBNM.
- Michael Dax June 2022: Wildlife Corridors and Connectivity; a
  presentation focusing on the implementation of the New Mexico Wildlife
  Corridors Act, signed into law in 2019. Dax is Western Program Director of
  Wildlands Network. During the 2019 session, Dax worked closely with legislative
  sponsors of the Wildlife Corridors Act prior to and throughout the legislative
  session that resulted in the passage of the bill.

#### Item 5: New Mexico Anti-Cruelty Laws: A White Paper Project of the Animal Law Section.

- ALS Board Member Yolanda Eisenstein organized this project. Board members Yolanda Eisenstein, Robert Berlin, Tracy Jenks, Christal Weatherly, and Guy Dicharry contributed to the paper.
- The writing group surveyed existing New Mexico anti-cruelty legislation at the state and local level in addition to outlining anti-cruelty and animal laws currently in place in Texas, Arizona, Maine, Oregon, Illinois, Colorado, Canada, Sweden, and Norway. The group wrote the paper to provide general information and insight on the scope of animal protection measures in several settings as compared to those currently in place in New Mexico. The section will make the paper available to New Mexico animal protection

advocates for use as a resource when deciding whether to propose anti-cruelty measures for action by New Mexico state and municipal law-making entities.

- 2. Meetings: The Board met on the first Wednesday of each month, except for December 2022.
- Continuing Education Presentation: The Section planned and hosted the annual Labor & Employment Law Institute on September 15 and 16, 2022. Both in-person and webinar options were made available.

4. Section/committee Annual Meeting: Our Section's annual meeting was held on September 16 in connection with the Labor & Employment Law Institute. Below are the talking points from the meeting:

Welcome! Thank you for attending in person or telephonically. I'm Caryn Carson, this year's chair of the ELLS Board.

Today's meeting will be short – the purpose is to update you on what's going on and provide an opportunity to ask questions.

Our biggest activity this year has been the planning and execution of the Employment and Labor Institute held yesterday and today. If you have feedback on the CLE, please let us or the Bar Foundation know.

The uncertainty surrounding COVID limited our activities for the first few months of 2022. However, in early June we held our first community event in more than two years at the Roadrunner Foodbank. It was a well-attended service event and a chance for some Board members and Section members to meet each other in person for the first time. Our hope is that 2023 will allow the section to continue more inperson events.

We supported law students at UNM who have an interest in employment and labor law. We funded a partial scholarship as well as four textbook stipends.

We urge you to get involved in the section. We are soliciting candidates for one open Director position. It is a three-year term starting in January 2023. We usually meet by phone on the first Wednesday of every month. If you are interested, please contact the Bar. There was also an email that went out earlier this month to members, and it had a link to follow if interested. The cutoff is Friday, September 30 at 5:00 pm.

We welcome ideas for additional section activities you would be interested in.

 Section/committee Outreach/Initiatives/Events: The pandemic limited in-person events during the first half of 2022, but on June 4, 2022 we held a volunteer event at Road Runner Food Bank in Albuquerque. It was attended by both Section members and members of the ELLS Board of Directors.



Additionally, the Board hosted a luncheon during the Labor & Employment Law Institute.

- 6. Scholarships: The Section funded the Richard Gonzalez Scholarship at UNM School of Law. The Section also funded four \$500 book stipends for students at UNMSOL. A CLE scholarship was also funded for one Section member during the Labor & Employment Law Institute.
- 7. Media: Our ELLS Board Coordinators were helpful in assisting the Board with e-mail blasts regarding the Labor & Employment Law Institute and other Section activities.
- 8. Ongoing Section/Committee Items: For 2023, the Section will offer its Labor & Employment Law Institute in the fall. It is also hoped that more in-person Section activities and community events will be possible.

The Family Law Section conducted and accomplished the following in 2022:

- 1. Board of Directors
  - Amber Macias-Mayo (chair); Sarah M. Armstrong (past chair); Kymberleigh Dougherty (chair-elect); Carlos Martinez (treasurer); Janine Caller (YLD liaison); Larry Heyeck; Randy Powers; Gretchen Walther (portion of year); Lucy Sinkular; Amy Bailey; Bridget Mullins; Kristin Bradford (portion of year); Bob Matteucci; and Linda Ellison.
  - b. Directors Kristin Bradford and Gretchen Walther resigned their positions during the 2022 year, which opened 2 additional positions, which were filled by Bob Matteucci, and later, Larry Kronen. Randy Power resigned their positions at the end of December 2022.
  - c. The Board members for 2021 and 2022 were strong, active and engaged in the various aspects of work within the FLS.
- 2. Meetings

Board meetings were held via video/teleconference on the 3<sup>rd</sup> Friday of each month. This has been the tradition with the Family Law Section and will continue for the 2023 year as well.

 Continuing Education Presentation(s) The Family Law Section continued to have a busy and productive year with continuing education presentations that included:

- a. The Spring Family Law Institute was held virtually and in person (hybrid) on April 8, 2022. The Spring FLI featured nationally renowned speaker Billy Eddy, Attorney and LCSW. Mr. Eddy presented on types and working with high conflict people. The CLE was approved for six hours of general credit;
- b. The Fall Family Law Institute, which was co-sponsored by the Solo and Small Firm Section, was held both virtually and in-person (hybrid) September 29 and 30, 2022. The Fall FLI featured presentations on financial aspects of family law cases including preparation of QDROs, business valuations, Dorbin analyses, and characterization of property; it also presented on issues involving civility and professionalism and well as transgender cultural fluency. The Fall FLI also offered an elaborate social component this year including an elaborate charcutier spread, sponsored by the Leigh & Dougherty, Family Law firm, and an array of delicious wines and beers, sponsored by the Macias-Mayo & Thomas, P.C., firm for members to gather and interact with each other, which has been unavailable for the past couple of years. The CLE was approved for 11.5 total credit hours with 1 hour of ethics/professionalism credit included.
- c. The Family Law Guardian *ad Litem* training was held both virtually and in-person (hybrid) on December 9, 2022. This CLE is the second of what is now an annual training session for individuals interested in performing GAL work in family law cases. The CLE focused on basic-level training and proposed standards for attorneys wishing to work as Guardians *ad litem* for children in domestic relations matters. 2022 presenters included Kathrin Kinzer-Ellington and Stepfanie Nicholson-Black, experienced GALs in Santa Fe, Sarah Armstrong of Albuquerque, Judge Jane Levy (former GAL) of Albuquerque, as well as a panel from the National Council of Juvenile and Family Court Judges training section who discussed domestic violence and its effect on GAL work. The CLE was approved for 6.25 hours of general credit. The Family Law Section intends to offer this GAL training annually.
- 4. Section/committee Annual Meeting
  - a. All Board meetings are open to members; no specific annual meeting held this year due to State Bar Convention being held virtually
- 5. Section/committee Outreach/Initiatives/Events
  - a. Developed and presented training for attorneys interested in work as Guardians *ad litem* for children in domestic relations cases;
  - Developed a "committee on the road" as outreach to state family law practitioners, which was stalled due to COVID and travel/gathering restrictions and but will pick up in the 2023 year;
  - c. The FLS hosted a meet-and-greet with the newly formed law student family law group to meet family law attorneys, establish relationships and provide mentoring as desired at Lescombes winery on May 12, 2022. The event was well supported and attended by the Family Law Section members;
  - d. Monitored family-law related legislation.

- 6. Scholarships
  - a. Provided scholarships to students from University of New Mexico School of Law to assist with payment of education expenses;
  - b. Provided scholarships to the judiciary and court services employees for attendance at the Family Law Institutes held.
- 7. Media (includes website and/or social media if applicable)
  - a. Fully activated member e-mail listserv to share information and send eBlasts of events;
  - b. Worked with the State Bar of New Mexico regarding new website content and usability
- 8. Ongoing Section/Committee Items:

For 2023, the Family Law Section intends to:

- Continue to hold monthly meetings and provide updates from those meetings to Family
   Law Section members by way of quarterly bullet-points or posting on website;



- 2. Meetings
  - a. The Board met monthly, typically on the last Friday of the month. Altogether, we had eleven (11) meetings to discuss ongoing business of the Section.
- 3. Continuing Education Presentations
  - a. One of Board's main accomplishments this year was our eight (8) Continuing Legal Education (CLE) presentations, including our annual immigration institute in December where we hosted four (4) back to back CLEs. - viii. Consular Processing: Family Petitions" presented on December 1, 2022
- 4. Section Annual Meeting
  - a. On November 10, 2022, we hosted our annual membership meeting where the Board of Directors presented a summary of our activities for the 2022 term.

The Indian Law Section conducted and accomplished the following in 2022:

- 2. Meetings (if applicable)
  - a. The ILS Board met six (6) times during 2022 starting in January 2022 and every other month thereafter. Additionally, the ILS Board met on November 3, 2022, coinciding with the Indian Law Section Annual CLE, for its Annual Meeting open to the membership. ILS met quorum for all, but one meeting.
- 3. Continuing Education Presentation(s) (if applicable)

a. The 2022 CLE Committee consisted of four members of the ILS Board of Directors: Josett Monette, Dianna Kicking Woman, Alyssa Mercado, and Garrett Davey.

In May, the Committee began the year with a ninety-minute panel co-hosted with the State Bar Equity in Justice Program titled "Native Women's Voices in the Law." The panelists were Helen Padilla, Terrelene Massey, and Alicianna Martinez. The panelists discussed their paths to the law, experiences in the legal field, and future hopes. A recording of the panel is available <u>here</u>. Later in May, ILS co-hosted a CLE Conference with the Paralegal Division. The panelists were Judge Catherine Begaye, who discussed the ICWA Court and the recent New Mexico Indian Family Protection Act; Judge Renee Torres and Judge Bruce Fox, both previous Tribal Court Judges, who discussed their experiences as State Court judges with prior Tribal Court experience; and Simon Tuck and Josett Monette, who discussed practicing in Tribal Courts.

In August, ILS is co-hosting a panel at the Annual Meeting for the State Bar. The panelists are Judge Knight and Judge Medina who continued their conversation from last year's Annual ILS CLE Conference, **Practice in Tribal Court: Ethical Rules**. In October, The CLE Committee also co-hosted a panel at the Diversity Committee CLE in October in which Judge Knight discussed *Brackeen* (ICWA) and the Political Status for Native American People. In November, ILS co-hosted the Probate Institute where Denise Zuni, Aaron Sims, and Emery McCabe presented New Mexico Perspectives on Tribal Probates.

Finally, the CLE Committee was busy all year planning the 2022 Annual ILS CLE Conference. ILS hosted the Annual CLE conference on Thursday, November 3, 2022. We had 11 speakers who spoke on a variety of topic in Indian law. Our speakers were: Senator Ivey-Soto and Kip Bobroff; Ann Tweedy; Denise Zuni and Sheila Herrera; Michelle Miano; Dr. Richard Luarkie, Stefani Cochran, and Raymond Etcitty; Jesse Heibel and Patrick Schaefer.


- 4. Section/committee Mentorship (if applicable)
  - a. The Mentorship Committee met bimonthly to discuss the balance between mentorship opportunities and increasing the bar passage rate of Native law school graduates. The Committee met with Professor Verónica C. Gonzales-Zamora at the end of the summer to discuss her success in supporting recent graduates in passing the bar. This conversation helped inform the committee's perspective on how to move forward with further discussions. The Mentorship Committee, along with members of the Board of Directors, participated in the UNMSOL Attorney Lunch and Learn hosted by the State Bar in September. Last, the Mentorship Committee met with UNM NALSA President Alma Buena to discuss bar passage rates and mentorship activities: UNM NALSA encouraged the Committee to participate in their planned bar prep workshops in 2023.
- 5. Section/committee Outreach/Initiatives/Events (if applicable)

- a. The Outreach committee met bimonthly throughout the year. It worked closely with the University of New Mexico's Native American Law Student Association to host two events at the Bow & Arrow Brewery. These events continued to establish and maintain links between UNM NALSA law students and NM BAR ILS law practitioners. In addition, the Outreach Committee worked with the Media committee to recognize two attorneys for their 2020 and 2021 Attorney Achievement Awards. Lastly, the Outreach Committee hosted a social mixer that followed the Annual Indian Law CLE at the Bow & Arrow Brewery. This event provided a forum for the discussion of Indian Law issues and its developments between Indian Law practitioners.
- 6. Scholarships (if applicable)
  - a. The Section awarded \$13,000 in scholarships to students in the year 2022. ILS, through the generosity of donors to the Karl E. Johnson Indian Law Scholarship, awarded \$1,000 to three (3) UNM School of Law students interested in practicing in the field of Indian Law. Approximately \$2,500 of funds will be carried over into next year. Additionally, ILS awarded \$2,000 to five (5) recent graduates for bar preparation. \$500 of the bar preparation fund will be carried over into next year.
- 7. Media (includes website and/or social media if applicable)
  - a. The Media Committee prepared a new issue of the ILS newsletter, the Indian Law Times, which was distributed to ILS Members and is available online <u>here</u>. The newsletter provides updates and announcements regarding the Indian Law Section's activities in both 2021 and 2022. The Media Committee additionally worked with the Outreach Committee to hold two award presentation events for recipients of the Indian Law Section's annual Attorney Achievement Award. Richard Hughes was presented with the 2020 Attorney Achievement Award at the Brakeroom in Santa Fe. This event had previously been postponed due to the pandemic. Peter Chestnut was presented with the 2021 Attorney Achievement Award at the State Bar Center in Albuquerque. The Media Committee additionally announced that Tom Luebben is the recipient of the 2022 ILS Attorney Achievement Award. An award event will be held for him in 2023.
- 8. Ongoing Section/Committee Items:
  - a. For 2023, the Media and Outreach Committees intend to coordinate an award ceremony to recognize the Indian Law Section's 2022 Attorney Achievement Award recipient. This will likely take place sometime in mid-year 2023.

#### Conclusion:

The Indian Law Section had a very productive year. The Section will be carrying over a healthy budget for next year. The Section is excited for 2023 and looks forward to continuing its endeavor of promoting the objectives of the State Bar within the field of Indian Law.


1. Board of Directors (if applicable)


7. Media



This is my report on the SSF section's activities and accomplishments in 2022.

- 1. **2022 Board of Directors:** Deian McBryde (chair), Charles Gurd (chair-elect), Brendan O'Reilly (secretary), Ian Bezpalko (budget officer), Lucy River, Marissa Crollett, Ashlea Crumley, Rebecca Mulcahy, Kymberleigh Dougherty, and Amara Aaron. One board member, Cindy Silva, departed the board before the completion of her term.
- 2. Meetings: The section board held regular meetings throughout the year.
- 3. **Continuing Education Presentation(s):** Once again, the SSF section provided excellent programming and great value to our dues-paying members, with opportunities for 9.0 hours of FREE CLE credit plus 6.0 hours of programming during our annual institute.
  - a. January 28, 2022: How to Plan for (Almost) Anything (1.0)
  - b. February 11, 2022: The New Notary Rules (1.0)
  - c. August 11, 2022: Solo & Small Firm Intensive at the Annual Meeting (3.0)
  - d. August 25, 2022: Intellectual Property: To Dabble or Not to Dabble (1.0)
  - e. September 23, 2022: Succession Planning Simplified (2.0)
  - f. October 20, 2022: 2022 Solo & Small Firm Institute (6.0)
  - g. December 21, 2022: Accounting & Tax Preparation Tips for Solo & Small Firms (1.0)
- 4. Section Annual Meeting: Wednesday, December 21, 2022, 9:00 a.m.
- 5. Section Outreach/Initiatives/Events:
  - a. August 11, 2022: Members' Lunch during SSF Intensive at the Annual Meeting
  - b. October 24, 2022: SSF hosted an In-Person Networking Event in Las Cruces.

- c. December 9, 2022: SSF co-sponsored a holiday gathering with the First Judicial District Court Bar Association in Santa Fe.
- d. December 15, 2022: Participated in the Doña Ana County Bar Association holiday gathering in Las Cruces.

## 6. Fellowships:

a. The section awarded 2022 fellowships to two members, Michelle Aucoin (Santa Fe) and Gillian Sherwood (Silver City), that included paid registration to the 2022 Annual Meeting and free participation in the SSF Intensive at the Annual Meeting. The section may continue to grow this opportunity.

## 7. Media:

- a. SSF maintains a Facebook group for members that remained largely inactive except for occasional posts of events made by the chair.
- b. The section's listserv remains active, although the "mailing list" functionality provided by the Bar is antiquated and inadequate. Nevertheless, members use the list to request support and referrals from one another, although they also continue to ask about more modern and effective technology.

## 8. Ongoing Section Items:

- a. The SSF Chair attended a meeting with the BBC Policy and Bylaws Committee on April 14, 2022, after which the section was advised that the BBC intended to force the section to modify its governance and bylaws to require a voting member of the SSF board appointed from the YLD membership by the YLD chair, not appointed by the SSF chair. The section requested that we be permitted to continue appointing non-voting liaisons from both the YLD and the SLD. The SSF board of directors objected to the bylaws changes as unreasonably forcing the section, which dues-paying members support, to have voting board members other than those selected by the section members or their duly elected board members. The single accommodation made to the section by the BBC was that the YLD voting board member must at least be a member of SSF, but otherwise, the BBC denied our request to determine this portion of our section's self-governance.
- b. Even before this unwanted intervention by the BBC, the SSF section's board was very diverse, with 40% of the SSF board being "young" lawyers (a term this chair finds discriminatory, ageist, personally offensive, and exclusionary). For the first time, women constituted a majority (60%) of SSF board members, and by year's end, the SSF board included several members from beyond the Albuquerque metro area, including from Santa Fe, Taos/Chicago, Las Vegas, and Deming.
- c. The section may continue working toward less dependence and reliance on SBNM's technology for listserv and member-to-member interaction, as the SBNM technology and website remain slow, unfriendly, and severely underperforming. SBNM has yet to fulfill the promised referral and interaction functionality since the technology "relaunch" announcement starting in at least 2018.
- d. The section continues to support solo and small firm attorneys in complying with the new mandatory succession planning rules in close cooperation with William Slease.

- e. The section enjoyed a budget surplus this year due to the successive rollover of funds during the pandemic, combined with the limited opportunities to gather with members from 2020 through much of 2022. The section might be expected to spend these resources more quickly during 2023 and 2024 and to be in a tighter cash position by 2025. With this in mind, the BBC should promote the section to a division in 2023 and provide a reliable budget based on the large numbers of solo and small firm attorneys.
- f. During 2022, the section's leadership continued to discuss the Board of Bar Commissioners' 2021 refusal to elevate the section from a dues-supporting section to a fully supported division of the Bar, given the substantial number of attorneys in the solo and small firm demographic. Operationally, the board did not pursue this topic during 2022, while the section focused on promoting succession planning initiatives and CLEs. This issue may resurface.

### **Chair's Conclusions:**

In 2022, the section saw growth in membership, dues, and self-funded resources. This year, our SSF members participated in the listserv, CLEs, and roundtables in reliable numbers and consistently expressed their appreciation to section leadership for the attention and programming provided by SSF.

Nevertheless, in my opinion, the BBC remains short-sighted by refusing to elevate the SSF to a division while providing substantial funding for the YLD and SLD, even though SSF is a larger percentage of the Bar's membership than either division. In particular, I am afraid that there is a bias in the BBC toward the YLD in budgeting for events, board travel, and marketing costs, as well as the BBC's now "choosing sides" with the YLD in forcing a change to SSF governance strongly opposed by the SSF board.

I believe the BBC should reconsider how to better support the approximately 38% of Bar members who practice in the solo or small firm practice setting, where funding might be used to assist attorneys who are struggling to maintain small businesses and practices far from the urban centers or to help new solo lawyers find mentors and other resources to develop their skills and grow their practices to sustainable levels. While promoting legal education, wellness, and other programs, the BBC has, in my opinion, mostly ignored solo and small firm practitioners as small business owners other than to now collect succession planning information required by the Court to ease the burden on the Bar. Speaking as a sole practitioner for nearly five years, the Bar has provided options for legal education but, until William Slease joined the Bar this year, has done very little otherwise to support us in growing or maintaining our businesses. There is new content; however, much of it remains, for all intents and purposes, invisible, locked in a user-unfriendly website that is difficult to use and navigate, where materials can easily go to die from a lack of promotion and regular use.

To my knowledge, and despite my frequent pleas, the Bar staff seems to believe they alone have the answers to all technology issues. I am not aware of any meaningful outreach by the Bar staff to create user groups, focus groups, or to encourage member input in the utility of the SBNM website, or none from SSF membership. The site seems to have been developed in a silo and remains locked away in it.

While the SSF section can attempt to address some of these issues, the section lacks ongoing, reliable resources to create meaningful grants, scholarships, and programming to reach the 3,500 other solo and small firm attorneys who are not dues-paying members of the section. The section is also limited by time and funds to provide working alternatives to the Bar's unwieldy website and Outlook email lists. I hope section leadership will continue to discuss this and engage the BBC toward more investments in reaching the BBC's constituency of solo and small firm attorneys.

Despite my many complaints, I am proud of the section and its members. I have seen the volume and depth of the interactions between members grow. Like all volunteer organizations, we struggle to find the time to produce with our hands the many ideas we create in our minds. And yet, we have done well.

For my two terms, my motto has been "Lawyers Serving Lawyers." I am pleased with the work and progress our board has made to do just that. I have also often said, "Being solo shouldn't mean feeling alone." I hope we have made an impact here, too. The larger issues of attorney loneliness, business anxiety and development, and personal <u>and</u> financial well-being are ones that our Bar should embrace more fully. We should not leave any members feeling as though they are alone.

I am grateful to the member services team in 2022, including Morgan Pettit and Addie Sanchez. I am concerned that a valuable team member, Morgan Pettit, was not retained by the Bar, despite her depth of knowledge, empathy for members, and boundless energy to accomplish a multitude of tasks. This was indeed a loss.

I also appreciate the work done by William Slease as a new member of the Bar's staff. Bill's knowledge and practicality have been constructive in helping Bar members with succession planning. I hope he is given the freedom to develop exciting programming that is useful and revolutionary rather than the staid task of implementing programs that sound good on paper or at conferences but are not practical in the day-to-day lives of those attorneys who practice in our communities and run small firms. I encourage the BBC to utilize Bill's wisdom, experience, and connections to provide rich programs for practice management.

I wish the incoming (and returning) section chair, Charles Gurd, good luck. I hope the SSF section board continues to be engaged at a level unseen on many volunteer boards, and I urge our Bar association to be a force for improving the practice, the profession, and the sustainability of our firms.

  - a. For 2023, the Section intends to have committees to coordinate the annual CLE program and the Career Day program.


