

The Alternative Methods of Dispute Resolution Committee of the State Bar of New Mexico conducted and accomplished the following in 2021:

- 1. Board of Directors
 - a. As a committee, the ADR Committee does not have a board of directors. There is an active steering committee of approximately 10 people.
 - b. 2021 steering committee members: Peter Merrill, Brandon Ilgen, Laura Bassein, Rachel Donovan, April McClellan, Jeff McElroy, Judith James, Jessie Lawrence, Josh Pando.
 - c. The steering committee met in February, July, and October.
- 2. Meetings
 - a. A full committee meeting was held in April, in which committee members discussed committee priorities and possible speakers for the remainder of the year.
 - b. A full committee meeting was held in July, with guest speaker Dathan Weems presenting on the topic of online mediation instruction.
 - c. A full committee meeting was scheduled for October but was cancelled at the last minute because of the unavailability of the planned guest speaker, Torri Jacobus. We are hopeful that Ms. Jacobus can present at a 2022 meeting.
- 3. Continuing Education Presentations

- a. The ADR Institute was held in December, with guest speakers Dawn Kuhlman and Naomi Paget presenting on the topic of trauma and stressors in ADR practice. More than 50 people were estimated in attendance based on the GoToMeeting record.
- 4. Committee Outreach/Initiatives/Events
 - a. The committee hoped to conduct outreach to UNM law students about the field of ADR and ADR-based law practice, and this has been included in our committee budget.
 Because of Covid, this effort continues to be on hold. As co-chairs, we are hopeful that the committee will be able to conduct this outreach in 2022.
- 5. Scholarships
 - a. Scholarships were provided to one committee member and one non-member attorney to attend the ABA Dispute Resolution Annual conference in April. Recipients were determined via a random drawing of interested entrants, with priority going to committee members.
 - b. One scholarship was provided to a committee member to attend the ADR Institute.
- 6. Ongoing Committee Items
 - a. For 2022, the committee intends to continue to promote speakers and educational events for committee members, State Bar members, and others in ADR practice.






The Committee on Women and the Legal Profession conducted and accomplished the following in 2021:

 - a. The CWLP met bimonthly during 2021 and held an end of the year dinner in December 2021. The meetings were all held virtually with the option to appear telephonically.
 - b. - 3. Continuing Education Presentation
 - a. The Committee hosted the Second Annual Women in the Law Symposium on December 9th, 2021. The half-day CLE was held virtually and included national speakers as well as an update from Dr. Amanda Parker on the New Mexico Supreme Court Commission on Equity and Justice. The other topics included Brokering Deals in Heels: From Mergers and Acquisitions to Italian High Fashion; Sonia Sotomayor: The US Supreme Court Approval Process and Other Insights Working in the Obama Administration; and Gender Discrimination and Sexual Harassment Complaints.
- 4. Section/committee Outreach/Initiatives/Events

- Despite the ongoing pandemic, CWLP still managed to complete a number of initiatives. The Gender Equality Handbook was updated and is in the process of being formatted for both legal professionals and pro-se litigants. Domestic Violence cards were updated, finalized, and printed. The Committee received numerous nominations for the Justice Pamela B. Minzner Award, although a recipient has not yet been chosen. Committee members attended a social event at Top Golf and a year end dinner at Fogo de Chao.



As Co-chair of the Legal Services and Programs Committee ("LSAP" or the "Committee"), this petition is written on behalf of the Committee, pursuant to Section 9.4 of the State Bar's bylaws, to petition the Board of Bar Commissioners to continue the Committee for an additional five years.

LSAP has a long history of putting into action the State Bar's support for the legal services system for provision of legal aid to low-income New Mexicans. Since the establishment of the Access to Justice Commission ("ATJ") in 2005, LSAP's mission has necessarily changed. Many of the functions which had previously been performed by LSAP were taken over—to great effect—by ATJ. Nevertheless, ATJ is limited in some aspects by its relationship to the Supreme Court. LSAP has found its mission, in part, in continuing to perform functions that ATJ cannot perform.

Although the activities of the Committee over the past five years are described at a high level below, it is worth highlighting the role LSAP played in the provision of legal services in New Mexico last year at the height of the COVID-19 pandemic. The Committee used its funding to purchase iPads for use at legal fairs/clinics in rural communities. Many of these communities do not have the resources to provide easy access to the technology necessary for virtual legal fairs (the organization of which LSAP has been involved with for many years). Additionally, LSAP funded scholarships in coordination with the State Bar's Diversity Committee for law students unable to take the Bar Exam due to delays related to COVID-19. The Committee also funded the creation of podcasts and pamphlets on a variety of legal issues to assist low-income families in need of legal assistance during COVID-19, in areas such as landlord/tenant cases and debt collection. The Committee's broad mission, along with the dedication of its members,

affords the Committee the flexibility to respond to crises afflicting low-income New Mexicans and ensure their access to legal support. The Committee is an asset to the Bar and the citizens it serves, and it should be allowed to continue its work.

- Meetings Not applicable. This committee does not meet *per se*. However, the New Mexico Medical Review Commission has told me that 99 different licensed attorneys (active and inactive) participated in its panels during 2021, many of them on a repeat basis.
- 3. Continuing Education Presentation(s) -- None


However, thanks to the N.M. Supreme Court's amendments to Rule 18-204 NMRA and the rule's implementation by thPe Board of Bar Commissioners, as of January 1, 2021, active attorney committee members could earn limited amounts of CLE self-study credits for serving on panels of the New Mexico Medical Review Commission. The commission does not know how many of the 99 attorneys serving on its panels requested CLE credit for doing so, but it reports it provided the necessary documentation for the attorneys to request the self-study credit from the Bar.

Section/committee Outreach/Initiatives/Events The Bar sent an email blast seeking new committee members to all active attorneys, on behalf of the committee in September 2021, and has been following up with quarterly Bar Bulletin announcements, to let attorneys know they'd be welcome as committee members. In other words, thanks to the work of the State Bar staff, many active and inactive attorneys joined the committee in 2021, either as first-time members or returnees.

Again with the critical assistance of the State Bar staff, the committee updated its page on the State Bar website, to provide a clearer idea of how the Medical Review Commission and its panels operate. The updated webpage also includes a link for attorneys to join the committee, which is a much simpler system for joining than the ones used in the past.

While hopefully this statement does not come to pass for busy legal professionals, it is a reminder that well-being is often overlooked but critically important aspect of every person's life. The Well-Being Committee has taken numerous steps to encourage and educate the legal community on tools and resources available to make time for their own well-being. The steps taken are too voluminous to go into with great detail in this annual report, but a brief summary of the committee's history, structure and accomplishments is contained in this annual summary.

The Well-Being Committee was incepted prior to the beginning of the Covid 19 Pandemic in an effort to encourage health and wellness among New Mexico lawyers. This committee was created with the intention of following the steps laid out by the National Task Force on Lawyer Well-Being. The NM Well-Being Committee is comprised of representatives from the bar, the law school, the Judiciary, and paralegal community.

To adequately serve all subgroups of our legal community, the NM Well-Being Committee divided into three subcommittees in July 2020, the Judicial Wellness Subcommittee, the Long Term Well-Being Subcommittee, and the Short Term Well-Being Subcommittee. The Subcommittees met as needed between the larger Well Being Committee Meeting which met every other month on the last Tuesday of the Month for about 1 hour. The short term solutions subcommittee had served its purpose of providing immediate events and was discontinued mid 2021. And now, the Judicial and Long Term planning committees continue their work along with the overall Wellbeing Committee.

There are several programs I would like to highlight for the BBC that the Wellbeing committee implemented and continued in 2021.

Overall Well Being Campaign

<u>What A Healthy Lawyer Looks Like.</u> The campaign included a monthly series of Podcasts and Articles designed to educate the legal community on a variety of wellbeing topics. The goal was that every judge, lawyer, law student, and legal staff person can find aspect of their mental, physical emotional, or spiritual health to improve upon.

Survey

Initially, when the Wellbeing Committee was first formed, the committee discussed the need for conducting a survey. Many different state and national surveys on wellbeing have been conducted and so the survey was tabled. After its first year of meetings, the Committee decided to conduct a survey specific to New Mexico and what needs the legal community identified in the area of well-being. The Survey was sent out the last part of 2021 and the results will guide the committee in the future. A copy of the key results is attached and includes responses from 777 lawyers.

Judicial Wellness Program

The Judicial Wellness Program (JWP) continued into the second and third phases of the 2020 plan.

The Judicial Wellness Subcommittee also sent out a survey to NM judges in October, 2021, on the need/want for more judicial mentoring/coaching. There was a 46% response rate and all levels of the judiciary were represented. The overall message was a resounding YES for wanting and needing more judicial mentoring/coaching resources. As of the end of 2021, the Judicial Mentor Coach Committee has plans in place to implement a Judicial Coach Resource in 2022.

- Phase I
 - Monthly JWell Now e-blasts continue to focus on well-being topics for the judiciary and are popular with approximately half of all state judges. E-blasts consistently have a 45-50% open rate.
 - The Judicial Wellness Committee delivered a holiday gift bag to every state judge the end of 2021. The gift bag included a fidget spinner, candy, and a card thanking them for their service and introducing them to Kelly Shane, the new Judicial Wellness Program Manager.
- Phase II
 - Judicial Roundtables started on weekly basis for all 67 Magistrate Judges September, 2020.
 - Judicial Well-Being Website was created in 2021 and is a repository of well-being resources, services, and information for judges.
 - Judicial Coaching/Mentoring Program improvement see above paragraph.
- Phase III
 - Confidential Assistance Program for Judges called JCall Now is being explored and will continue to evolve in 2022 as part of a larger Judicial Wellness Program for judges.
 - Judicial Standards Committee Collaboration started in Oct. 2020 to address the stigma judges feel when thinking about reaching out for help. This collaborative effort will continue for years to come.

Senior Justice Vigil stepped down as co-chair of Judicial Wellness Subcommittee, when she retired in June 2021. Pam Moore continued to lead the group as co-chair. Kelly Shane, the new FT Judicial Wellness Program was hired in 2021 and will assume chair of this committee as of February, 2022. Kelly's duties include chairing the Judicial Subcommittee, crafting and maintaining the JWell Now Emails, and continuing to grow and develop the JWP including resources and services available for judges. In addition, the JWP will be the home of the Judicial Coach Resource for mid to later career judges.

Future Goals and Plans

2022 What a Healthy Legal Community Looks Like

The Well-being Committee's goals in 2022 will be geared toward understanding the state of well-being in legal organizations including, Large and Small Firms, Paralegals, Law Students, Government Attorney Practice (District attorneys, Public Defenders, and others). Topics for the podcasts and Articles so far include an introductory article, Solo and Small Firms, UNM Law School and the Attorney General's office.

Future Committee Members

The Well Being Committee is in the process of creating rules for the appointment of its members so that the is a clearly defined process for those who wish to join the committee can do so but also keeps the number of members at a manageable level.

Re: Petition to Continue the Animal Law Section

Dear Commissioners:

As the chair of the Board of Directors of the Animal Law Section (ALS) of the State Bar of New Mexico (SBNM), I write on behalf of the Board and with the approval of the full Board to petition for continuance of the ALS. The ALS has established itself as an important information resource for attorneys and for the public generally in the field of animal law. For the reasons set out below, the Board asks the Commissioners to continue the section.

1. Services and activities provided by the ALS.

a. *Board Meetings*. The ALS Board holds at least six regular meetings each year to discuss section business, plan CLE events and our Animal Talk series, and to generate ideas for continuing outreach to the legal community and the non-lawyering public regarding laws affecting wildlife and domestic animals.

b. Continuing Legal Education.

- The ALS presented the following seminars for CLE credit:
 - September 2016: Animal Law: Wildlife and Endangered Species on Public and Private Lands— The Tipping Point
 - May 2017: Legislative Roundup
 - August 2017: The Law and Bioethics of Using Animals in Research
 - November 2018: Updates, Causes of Action, and Litigation
 - o May 2019: Legislative Roundup
 - November 2019: The Law and Ethics of Wild Animals in Captivity
 - November 2020: Rollbacks to Wildlife Protection Under the Trump Administration, and the Way Forward (Collaboration with the UNM School of Law)
 - November 2020: Ethical Questions in Representation of Animal Law Cases

- April 2021: Legislative Roundup (Collaboration with the UNM School of Law)
- Upcoming in November 2021: Companion Animals: Hot Topics in Law and Ethics.
- The Animal Law Section Legislative Roundup began after the 2015 Regular Session of the New Mexico Legislature and now takes place following the 60day sessions of the New Mexico Legislature. Panelists include John Crenshaw, President of the New Mexico Wildlife Federation and Jessica Johnson Shelton, Legislative Director for Animal Protection New Mexico. Both work as lobbyists during the legislative session. For the 2021 Legislative Roundup, state Senator Brenda McKenna joined our group of panelists. Senator McKenna co-sponsored animal-related legislation during the session, including the bill to ban trapping on state and federal public lands in New Mexico that passed both houses and was signed into law by Governor Lujan Grisham.

During the 2017 and 2019 sessions of the New Mexico Legislature, the ALS used the Facebook page to track and to post links to animal-related legislation introduced during the session. Visitors to the ALS Facebook page were able to download a list of bills with active links to the bill, committee reports, action taken, and fiscal impact report.

e. *Animal Talk.* This is a series of one-hour talks open to the public. The talks take place approximately three to four times during the year, although the interval can vary. Animal Talk started in 2013 with the goal of engaging the public and the legal community in discussion of legal issues relating to animals.

- December 2016: Courthouse Facility Dogs -- how professionally trained courthouse facility dogs are working throughout the country in prosecutors' offices, child advocacy centers, and family courts to assist crime victims and other individuals while they participate in stressful legal proceedings.
- March 2017: Appellate counsel discussed the legal issues arising out of the City of Albuquerque Trap, Neuter, and Return Program.
- June 2017: Protecting Pollinators: Laws, Policies, and Action. Federal, state, and tribal protections for pollinators. Julie McIntyre, Pollinator Coordinator for the Southwest Region of the US Fish and Wildlife Service.
- April 2018: Tethering Dogs: Implications for Public Safety and Humane Treatment.

- June 2018: The Migratory Bird Treaty Act Turns 100. Jonathan Hayes, Executive Director, New Mexico Audubon Society.
- September 2018: Animal Cruelty: evidence of the crime, and the proper crime to charge. Presented by Captain Andi Taylor, Bernalillo County Sheriff's Office.
- January 2019: Preview of Animal-Related Bills Introduced in the 2019 Regular Session of the New Mexico Legislature.

f. New Mexico Lawyer. The ALS and NREEL collaborated to produce the October 2020 issue of the New Mexico Lawyer: The ALS was responsible for two of the articles in the issue.

- "Wildlife and Federal Regulatory Rollbacks Under the Trump Administration" by Nicholas Arrivo and Bruce Wagman.
- "The Migratory Bird Treaty Act: Intentional vs. Incidental" by Guy Dicharry.

2. Thanks to the SBNM Staff.

The ALS appreciates the SBNM staff who work hard to help us do the things I have listed above. The staff helps us reach our section members and the New Mexico Bar with important information. Each edition of the New Mexico Lawyer requires coordination among the ALS, the editorial board, and the SBNM staff. The ALS uses E-blasts for a variety of reasons and it is the SBNM staff who makes sure that the communications are timely and accurate. The SBNM staff also publishes weekly announcements of Animal Talk presentations in the Bar Bulletin for a period of at least 2 - 3 weeks prior to each talk. Each of the Animal Talks requires a reserved room, chairs, tables, snacks, and a variety of A-V equipment depending upon the presenter. The SBNM staff makes sure our financials are up to date and helps us maintain compliance with some of the lesser-known provisions of our Bylaws. Our board works hard to achieve our goals and we acknowledge the assistance we receive from the staff at the State Bar.


3. Conclusion.

The Section conducted the 32nd Annual Appellate Practice Institute on September 10, 2021. This annual, full-day CLE program is well-known and well-attended. Although it was planned as a combined live/virtual presentation, developments with COVID-19 resulted in a late but successful transition to a fully virtual format, as was the 2020 API. This program is devoted to appellate practice issues and related issues of ethics and professionalism, and members of the New Mexico appellate judiciary generously participate in many of the segments, with experienced appellate practitioners carrying the rest of the programming. This year's API featured a keynote speech by New Mexico Supreme Court Justice Shannon Bacon and an update on the status of oral argument in the New Mexico Supreme Court and the Court of Appeals by Justice David Thomson and Judge Zachary Ives, which remarkably did not focus on virtual arguments. Retired Justice Edward Chavez and Bill Slease of the State Bar finished up the program with a conversation about professionalism and ethics in appellate practice.

- 4. The Section's Annual Meeting was held virtually on October 12, 2021.
- 5. Section/committee Outreach/Initiatives/Events
 - Brown Bag Lunches with NM Appellate Court Judges, in which the Section invites appellate judges to meet with Section members and other interested participants for a discussion of appellate court-related issues. The section had a brown bag lunch with Judge (now Justice) Briana Zamora and Judge Jacqueline Medina on June 11, 2021, and another brown bag lunch with Judges Zachary Ives, Megan Duffy, and Jennifer Attrep and Justices David Thomson and Shannon Bacon on December 10, 2021. The Section's Board is delighted that Judge Ives asked to speak at the brown bag lunch because he had more to say than he was able to

cover during the API, and that Justices Thomson and Bacon also were eager to rejoin our group after the API. The COVID-19-inspired virtual format has increased member participation considerably compared to lunches at the State Bar Center.

- b. The Section is in the process of preparing a newsletter for Section members.





2. Meetings


- a. Annual Meeting The CLS Annual Meeting is held each January during the Children's Law Institute. Due to the pandemic, the 2021 Children's Law Institute was virtual, as was the Annual Meeting which occurred on Thursday, January 14th, 2021 at 3:00 pm MST. About 55 people attended virtually, asked questions, and learned about CLS.
- b. Board Meetings For more than half the year, the CLS Board met monthly on the second Wednesday of each month. Due to conflicting schedules and events,

the Board voted to change the meeting day and time. Starting in October, CLS changed the monthly meetings to the second Thursday of each month.

- 3. Continuing Education Presentation(s)
 - a. CLS supports the Children's Law Institute which is a state-wide, multidisciplinary conference of roughly 1,000 attendees which focuses on issues pertaining to child welfare and juvenile justice. At this conference, attorneys have the opportunity to complete their required, yearly CLE's. Members of CLS were instrumental in the planning of the 2022 CLI held January 12 14, 2022.
- 4. Section/committee Annual Meeting
 - a. The CLS Annual Meeting was held virtually on January 14, 2021.
- 5. Section/committee Outreach/Initiatives/Events
 - a. Art Contest CLS held the annual Art and Writing Contest with the 2021 theme *"Rhythm of the Soul…"* Children and young people whose lives have touched the Children's Court system were eligible to submit a piece of art, photography, or writing pertaining to the theme. Although the contest was more widely advertised via email than ever before, again, submissions were low. Members from the National League of American Pen Women, Yucca Branch provided the judging for the contest.
 - Reunification Boxes In September, the section again voted to donate money for the purchase of gift boxes for families in the abuse and neglect system who successfully reunified.

 - a. Each year, CLS donates a large amount to the Children's Law Institute (CLI), which is in turn used for scholarships to their annual event. In 2021, CLS donated \$1,000 for the January 2022 CLI.

5. Section/committee Outreach/Initiatives/Events



- **Board Certification.** The Section has promoted Board Certification to recognize the experience and knowledge of New Mexico's Health Law Attorneys.



Lastly, the 2021 Scholarship recipients were announced.

8. Ongoing Section/Committee Items:





Ultimately, the Board will continue to participate so that law students interested in the practice of public law will be prepared to enter public practice.

- 6. Scholarships:
 - a. The Board had carry-forward funds from Section dues from the prior year and with those funds awarded nearly \$1000.00 in additional scholarships that were disbursed to UNMSOL students interested in public law. APIL scholarships recipients have used the funding to launch their careers in public interest law and take unpaid public interest positions in 2021.

In addition, every year the Section awards the Othmer Scholarship with the assistance of Craig Othmer's family. The Section matches funds from the Othmer family to creates a generous \$3,000.00 scholarship for a student working in an unpaid public service summer position. This year's awardee was Carson Thornton González, a 1L at UNMSOL. She was born and raised in Albuquerque. Carson is passionate about criminal justice reform and worked as a legal intern with the New Mexico Prison & Jail Project (NMPJP). NMPJP is a new criminal justice organization that was founded specifically targeting the criminal justice system in New Mexico, filing civil suits on behalf of incarcerated individuals.

 - a. The Section is thankful for the efforts by the State Bar to update the webpages, making them easier to navigate and more useful for members.  - iv. continue to plan and implement our annual programs and help ensure that the Section is a relevant and useful organization for our membership and the State Bar.







The (section/committee name) conducted and accomplished the following in (year):

1. 2021 Board of Directors

As Chair, I have worked diligently to increase Board engagement and promote greater involvement in the Section by empowering Board members to develop programing of interest to them to allow programs to be brought to Trial Practice Members that live in different parts of the State. In 2021, the Board consisted of the following members, who represented multiple practice areas and live in various areas across the State:

The Board also worked to identify persons who would be interested in serving as a UNM School of Law Student liaison, since that position had previously been unfilled. Kaleb Brooks identified and obtained letters of interests from UNM School of Law students, and the Board chose among the applicants to

serve in 2022. We are encouraged that this appointment will allow for greater collaboration between the Trial Practice Section Board, the members of the Section, and UNMSOL. The Board has also added new members for the 2022 year to ensure even greater outreach and opportunity for planning events in 2022.

2. Meetings

The last Thursday of every month, the Trial Practice Section met together to discuss plans for programming and the annual CLE.

3. Activities & Action Items Undertaken/Continuing Education Presentation:

- a. The Board spent a substantial amount of time and resources planning for an annual CLE on December 16, 2021, which was held virtually and well attended. The programming allowed attendees to obtain 6 General credits and 1 Ethics/Professionalism Credit. The topics were wide-ranging and included themes and areas of interest to the membership, including in both the civil and criminal context. The final presentation of the day was presented by Justice David Thomson of the New Mexico Supreme Court, Judge Katherine Wray of the New Mexico Court of Appeals, and Judge Gerald Baca of the New Mexico Court of Appeals. Chairperson Breanna Contreras and Board Member Brendan O'Reilly moderated the panel discussion related to trial practice issues, including preserving issues for appeal, discovery challengers, and practicing in COVID times moving forward. A copy of the 2021 Trial Law Institute CLE agenda is attached.
- b. The CLE also presented another opportunity to remind attendees and members of the Trial Practice Section of the unique and comprehensive Trial Database established by last year's Chairperson, Carter Harrison, which provides detailed information concerning over 4,200 jury trials in civil and criminal jury cases in New Mexico's state courts since July 1, 2017, and vives information concerning claims/charges, presiding judge, and case outcomes for the Trial Practice Section's membership to utilize information in their own practices. - c. In addition to the December 16, 2021 Trial Law Institute, the Board has organized other events throughout the year, including a Lunch with Judges Program in collaboration with the Young Lawyers Division on April 23, 2021.
- d. We've begun interacting with law students at UNMSOL to facilitate smaller CLEs, brownbag lunches, and social events, with the need to postpone most programming due to various COVID-19 surges during 2021
- e. The Board voted to provide scholarships and sponsorship support with respect to two programs in 2021:
 - i. \$1000 contribution to the Gene Franchini Mock Trial Program
 - ii. \$500 to the Judicial Clerkship Program

f. The intent of the Board is to save resources from 2021 to allow for more in-person programming in 2022 as COVID restrictions are loosened

4. Ongoing Section/Committee Items:

- a. For 2022, the Trial Practice Section intends to increase programming, diversify the Board including areas of practice, minority membership, and geographic membership to allow for a better representation of the Section's membership, and to increase program offerings in 2022.
- b. The Board expects to begin planning new interesting CLE programming with one or more national speakers and state and federal judges
- c. The Board also expects greater collaboration with UNMSOL now that the Board has a 2022 Liaison from the SOL.
