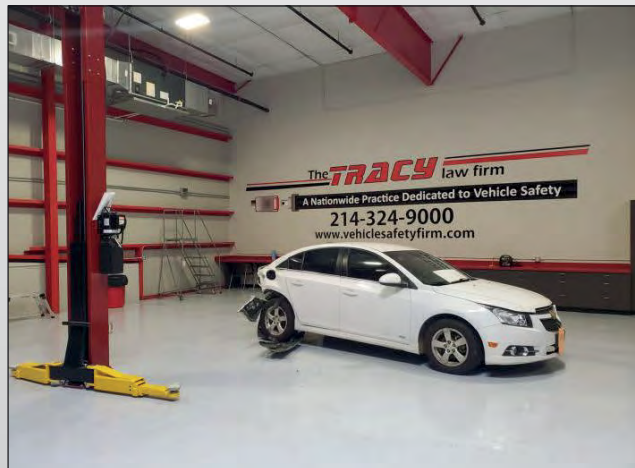
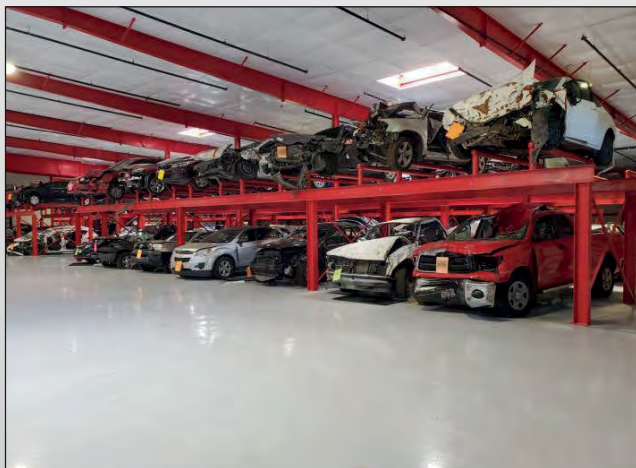

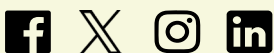

New Mexico Supreme Court Administrative Orders Regarding Provisional Amendments to Pretrial Release Rules and Competency Cases in the Metropolitan Court

Administrative Order Regarding the Provisional Amendment of Rules 5-401, 5-403, 6-401, 6-403, 7-401, 7-403, 8-401, and 8-403 NMRA

The Supreme Court issued Order No. S-1-AO-2025-00013 on July 29, 2025, which approved provisional amendments regarding pretrial release to Rules 5-401, 5-403, 6-401, 6-403, 7-401, 7-403, 8-401, and 8-403 NMRA. The administrative order is available on the Court's website at <https://supremecourt.nmcourts.gov/rules-forms-files/administrative-orders/>.

Administrative Order Regarding the Suspension of Rule 7-507.1 NMRA and Criminal Competency Proceedings in the Metropolitan Court

The Supreme Court also issued Order No. S-1-AO-2025-00014 on July 29, 2025, which suspended Rule 7-507.1 NMRA, following recent statutory changes, and requires criminal competency proceedings in the metropolitan court to be governed by Rule 6-507.1 NMRA. Supreme Court of New Mexico Announces the Conclusion of its 2024-2025 Term and the Commencement of the 2025-2026 Term

At its February 2024 administrative conference, the Supreme Court of New Mexico approved sitting in terms. The Court's first term began in the Fall of 2024 and concluded on July 15, 2025, with the Court having resolved all 59 cases submitted since September 2024. In addition to resolving the 59 term cases, the Court also disposed of 39 non-term cases. In total, the Court filed dispositions in 98 cases from September 2024 to July 15, 2025.

The 2025-2026 Term will begin this fall, with oral arguments in the months of September, October, and December. Dispositions for all cases submitted during the Court's 2025-2026 Term will be filed on or before July 15, 2026. The Court will continue to set expedited appeals in accordance with Supreme Court Order No. 23-8500-016, In the Matter of the Modification of the Policy Expediting the Process for Specific Categories of Case upon the Issuance of Writ of Certiorari.

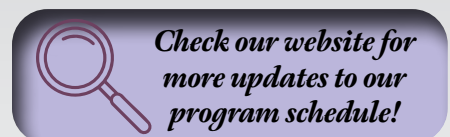

Defendant Von Marquez appeals the district court's denial of his motion to suppress evidence obtained from a warrantless search of his backpack. The district court concluded that the arresting officers conducted a valid inventory search. On appeal, Defendant argues that the district court erred because the State's justification for inventorying the contents of the backpack does not suffice under the Fourth Amendment of the United States Constitution and Article II, Section 10 of the New Mexico Constitution. In response, the State focuses on its argument—made for the first time on appeal—that Defendant lacks standing to challenge the search because he denied owning the backpack and because he abandoned the backpack before his arrest by leaving it in an apartment in which he did not reside. Plaintiffs, Gustavo Davila and Graciela Davila, appeal the district court's order granting summary judgment in favor of Defendants Milton Jeff (Jeff), MVT Services, LLC, OEP Holdings, LLC, Penske Truck Leasing Co. L.P., MVT Leasing, LLC, and John Does 1-10 (collectively, Defendants). We agree with the district court's rulings that: (1) Plaintiffs were required to but did not provide expert testimony to establish either (a) causation for the tire disablement, or (b) the standard of care asserted by Plaintiffs for responding to a commercial vehicle tire disablement; and (2) the statutes identified by Plaintiffs to support the claim for negligence per se did not meet the required criteria.
