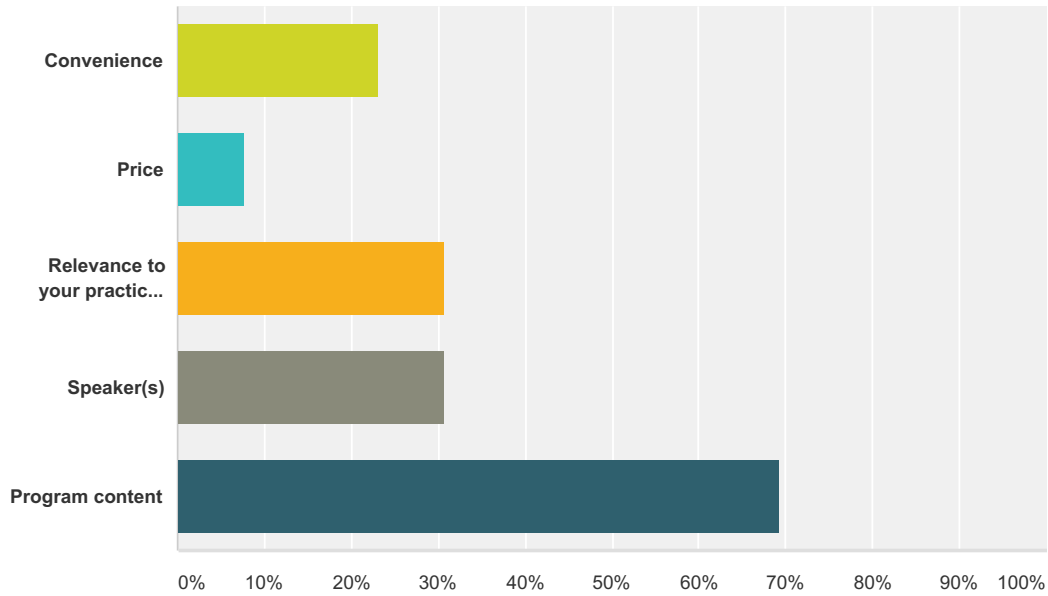


Q1 What factor was most important to you in deciding to attend the Sept. 18, Using Creative Legal Strategies to Protect Animals, People and the Planet CLE program?

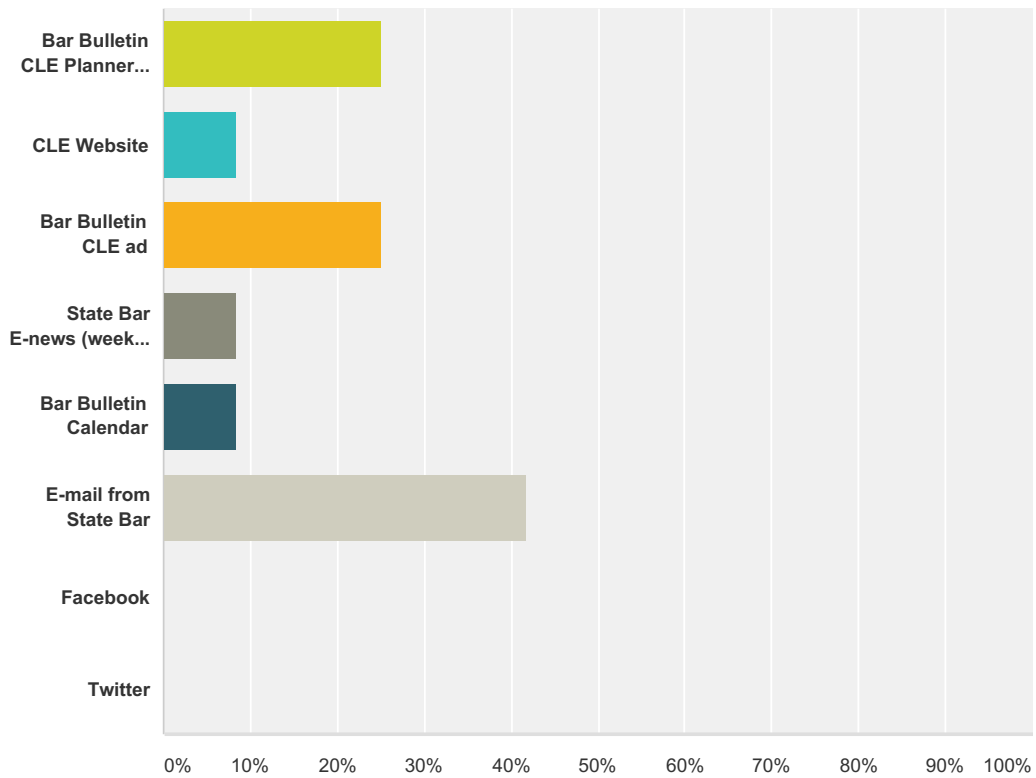

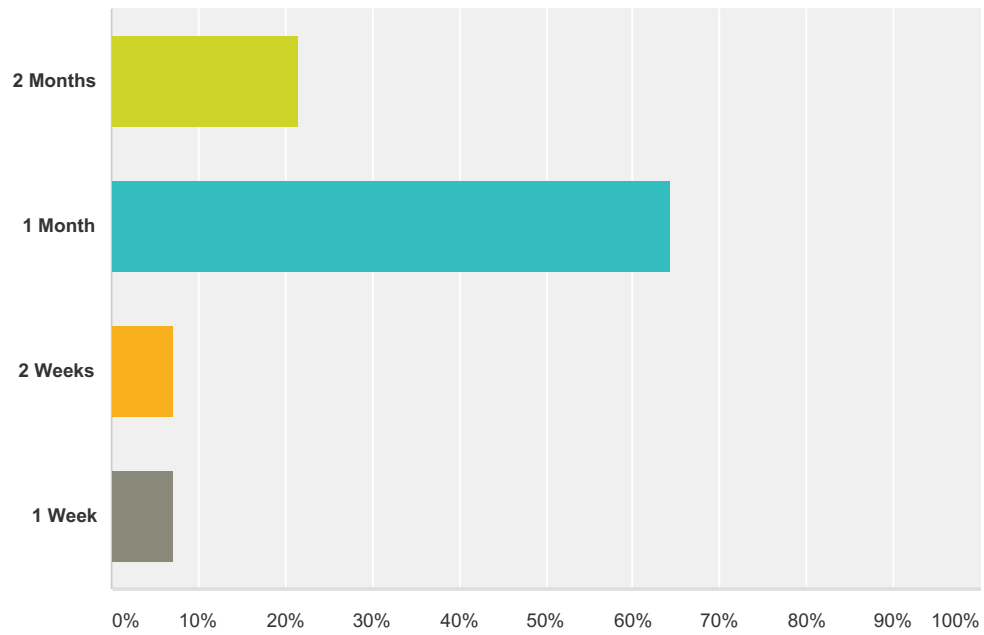

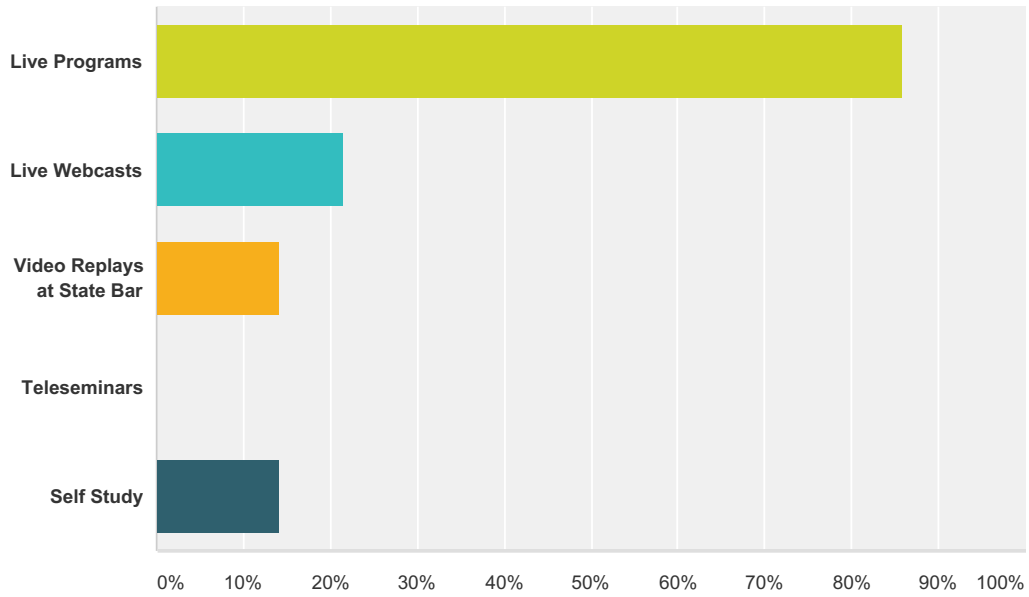

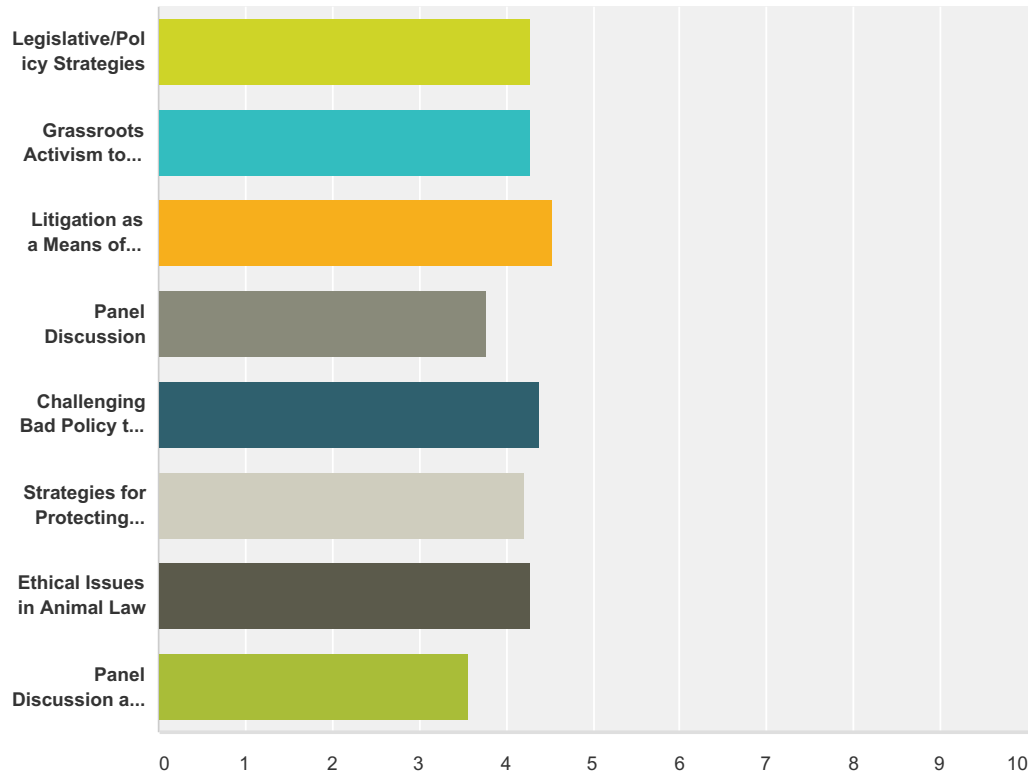

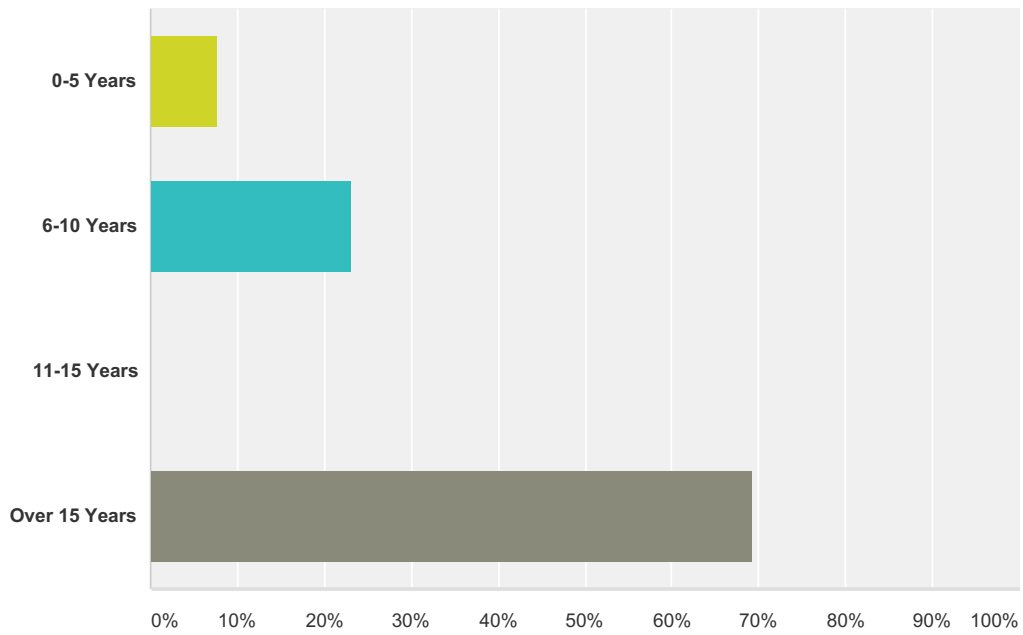

Q8 How many years have you been in your area of practice?

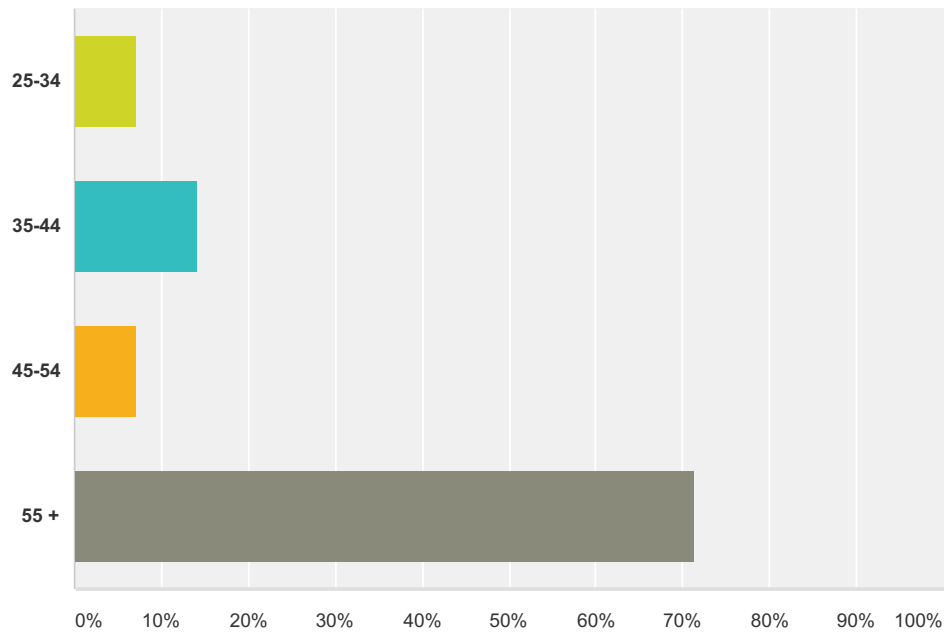
