




Q9 Which of the following best describes your age?



The presentations were a feedback loop of recycled opinion. Furthermore, the amount of legal presentation, analysis, and discussion could not have exceeded 25% of the program. The bulk of the material presented focused on the individual speaker's policy preferences, whilst attacking policy's that diverged from that presented. The Animal Law Section, in what can only have been a deliberate effort, did not invite divergent opinions to present and defend valid, yet diverging legal and policy positions. A CLE undermines its own credibility when it fails to incorporate diverging legal and policy opinion. The New Mexico Bar Association would be wise to provide greater oversight of the Animal Law Section before it sponsors CLE and other events that carry the Association's credentials.	9/15/2016 9:00 AM
