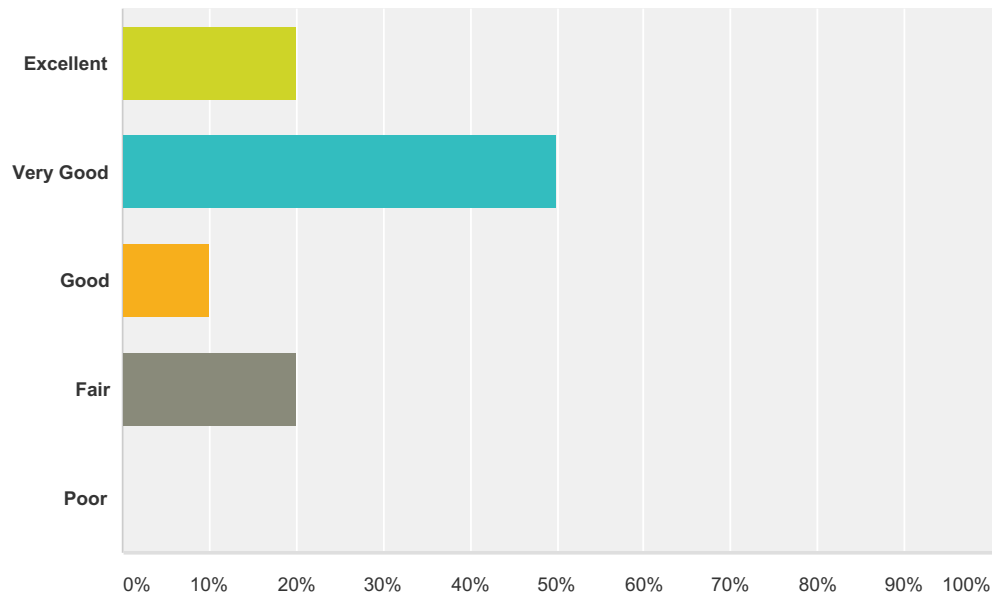


Q1 Overall, how would you rate the quality of this CLE Program?

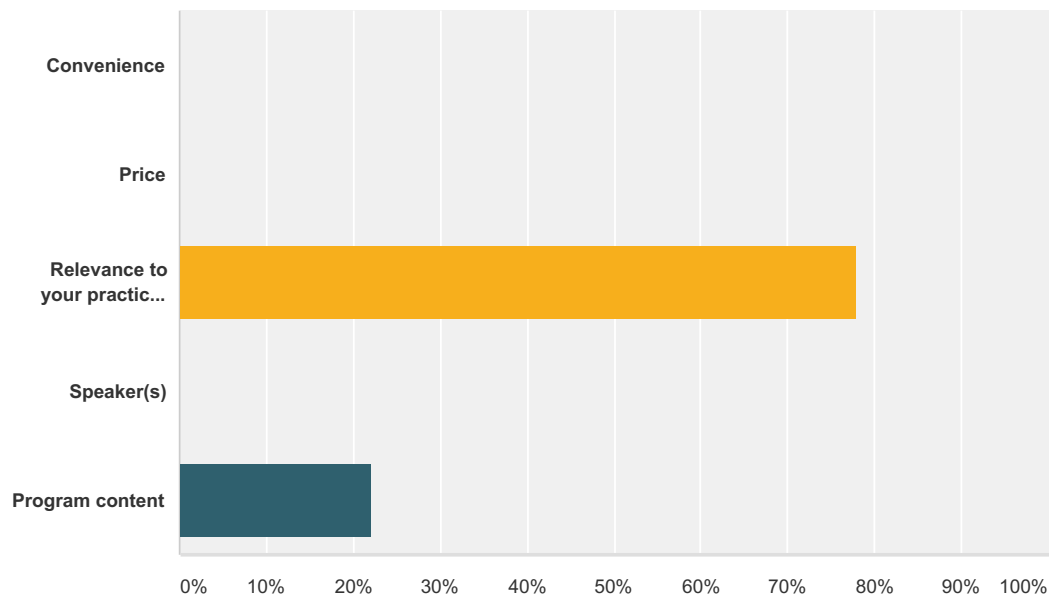

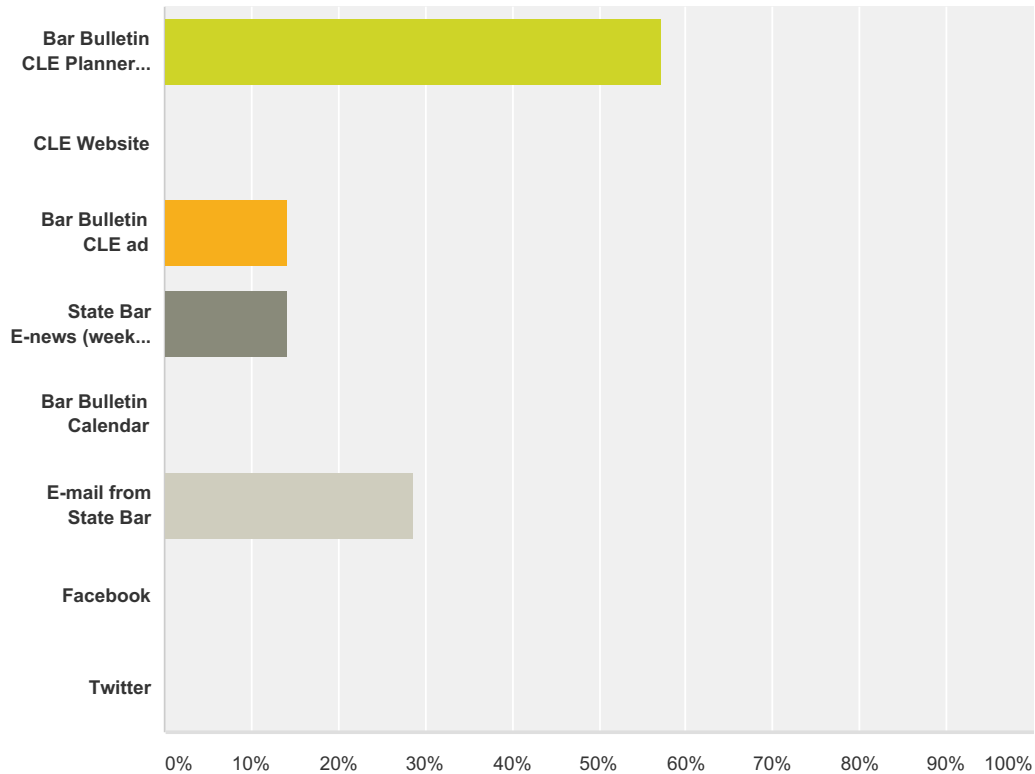

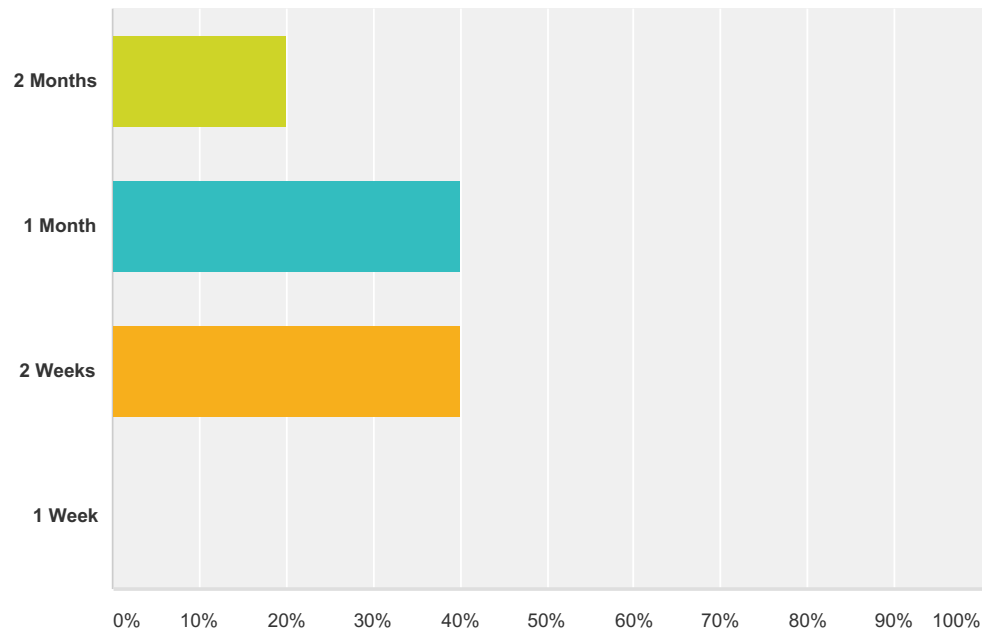

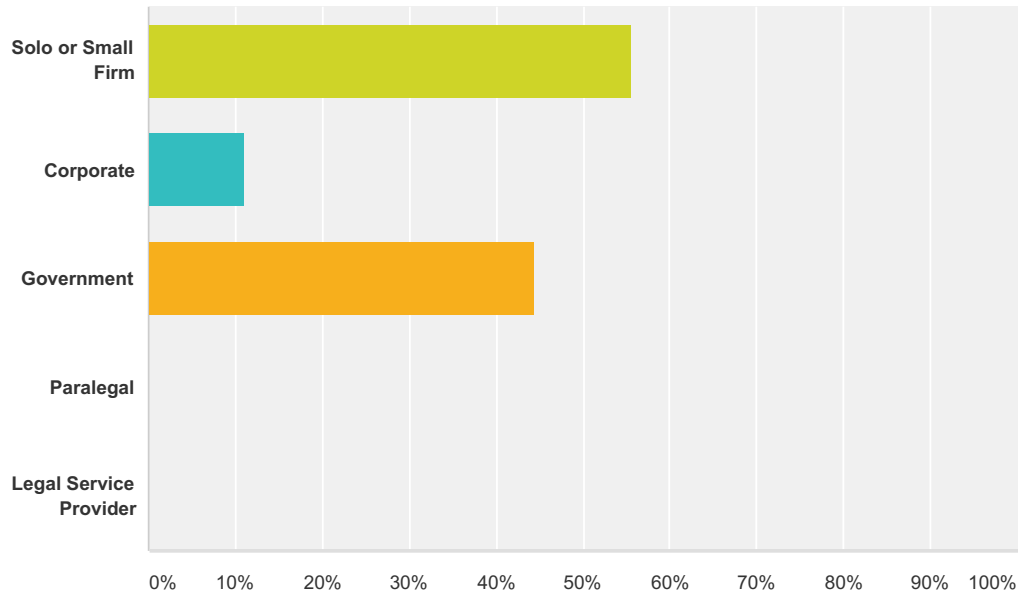

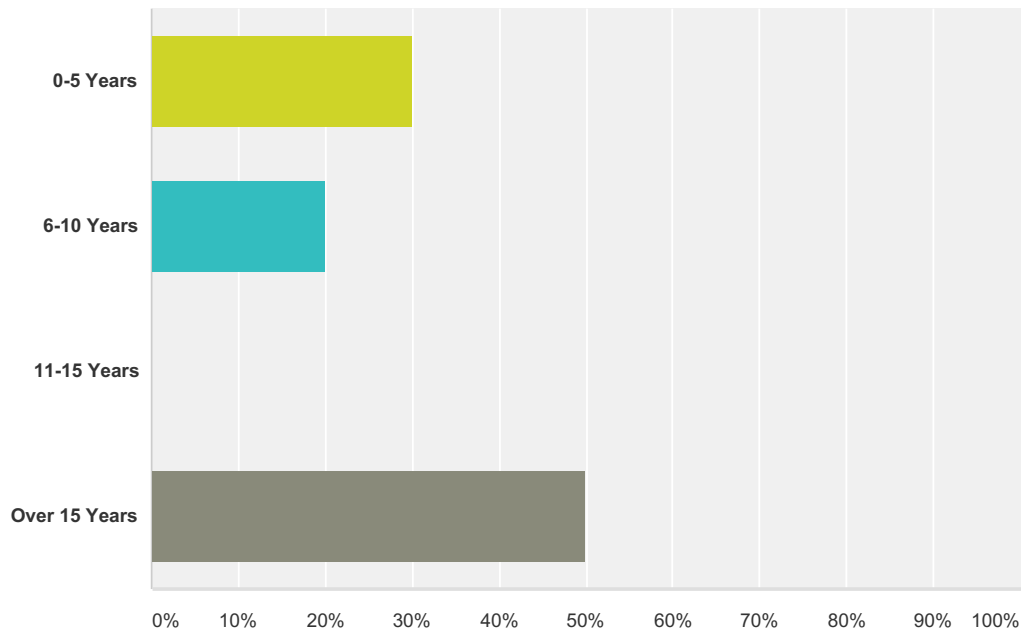

Q8 How many years have you been in your area of practice?

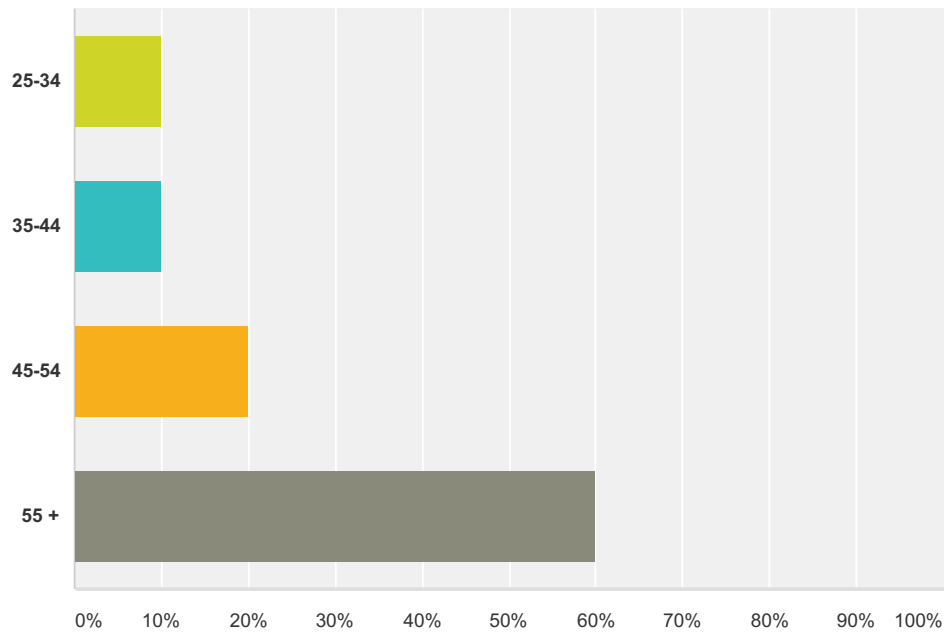

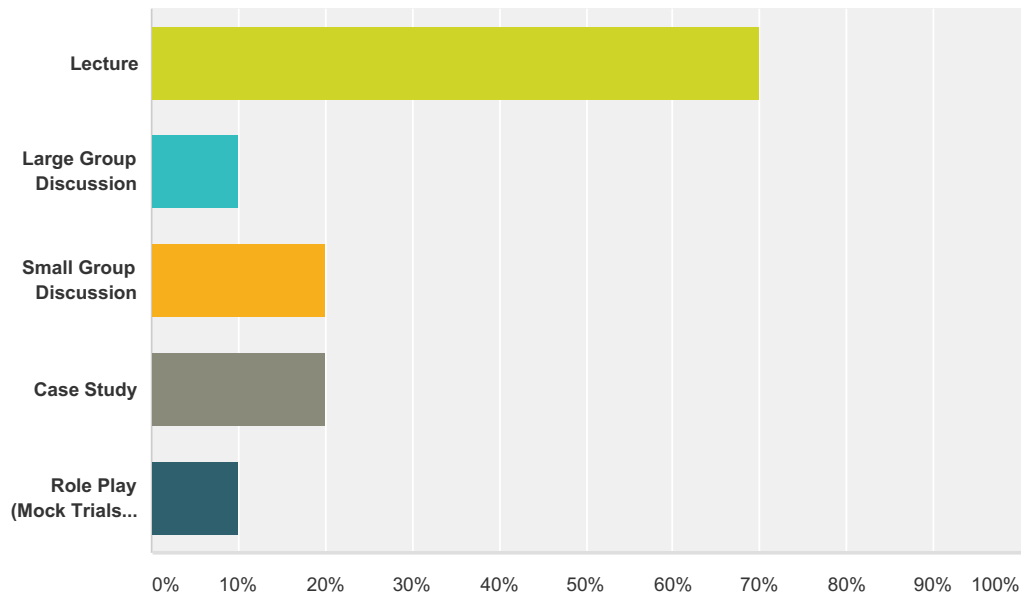

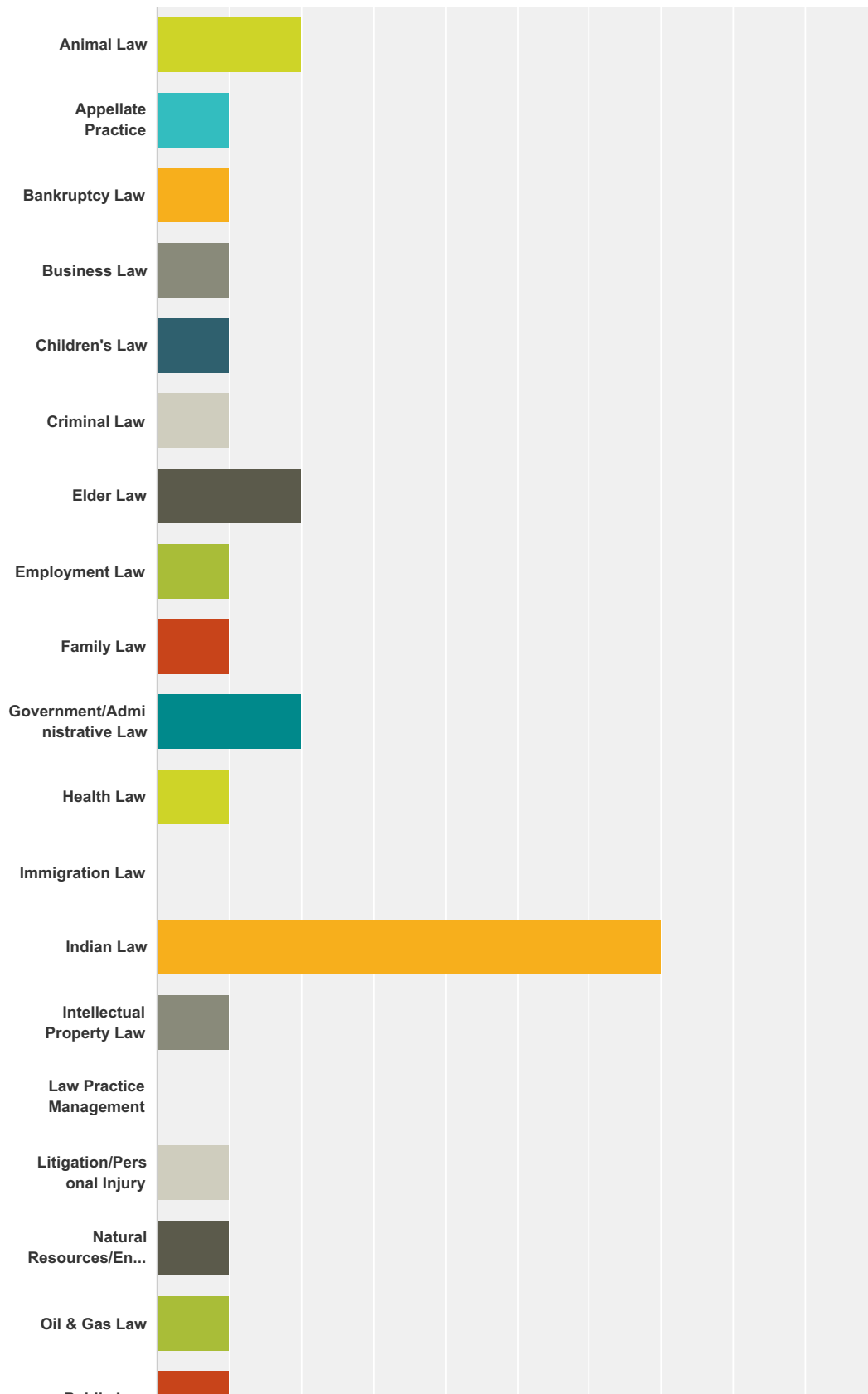
