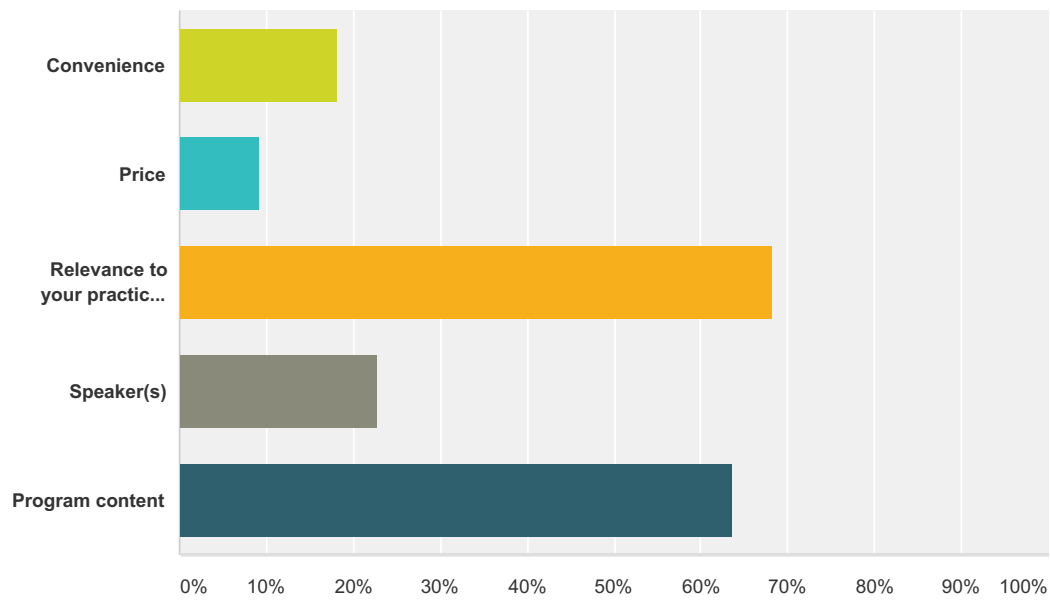


## Q1 What factor was most important to you in deciding to attend today's program?

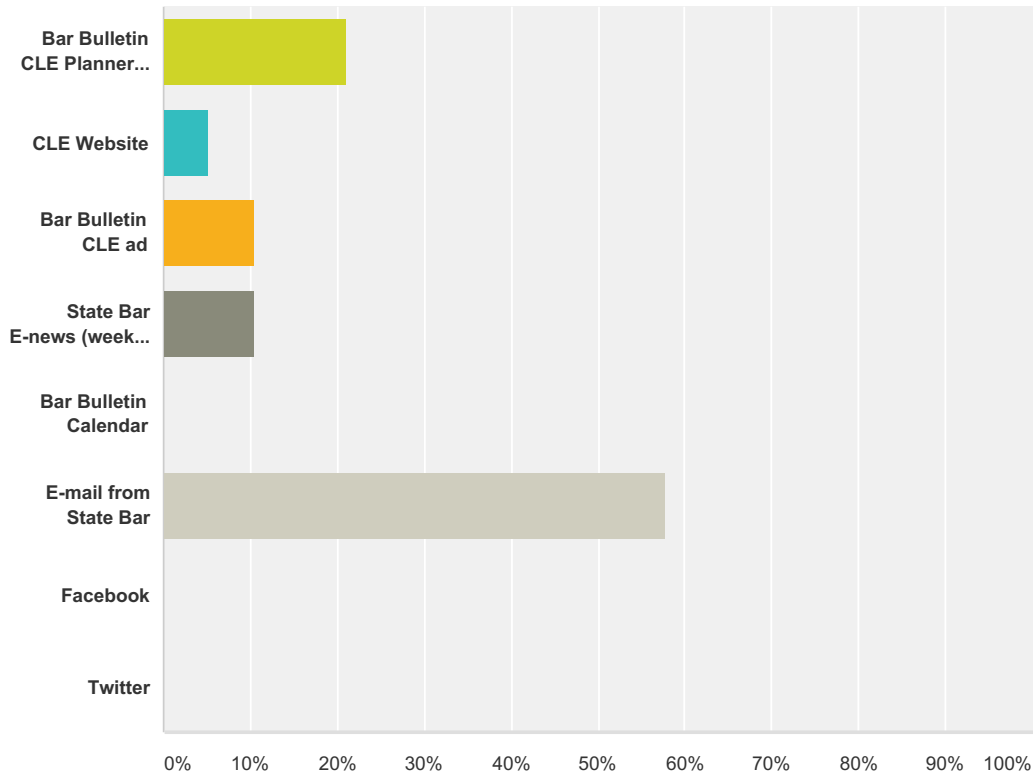

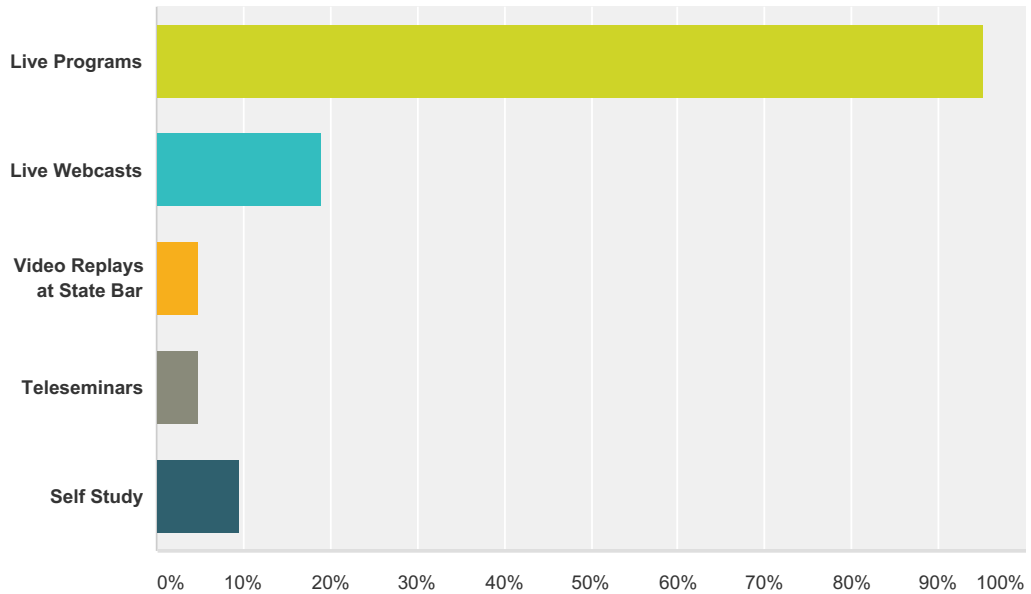

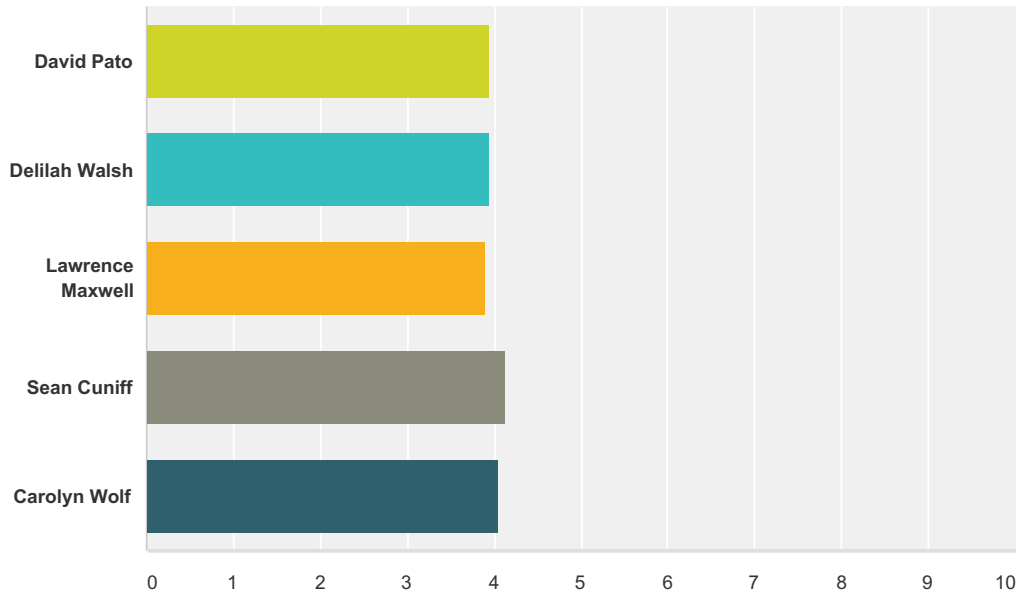

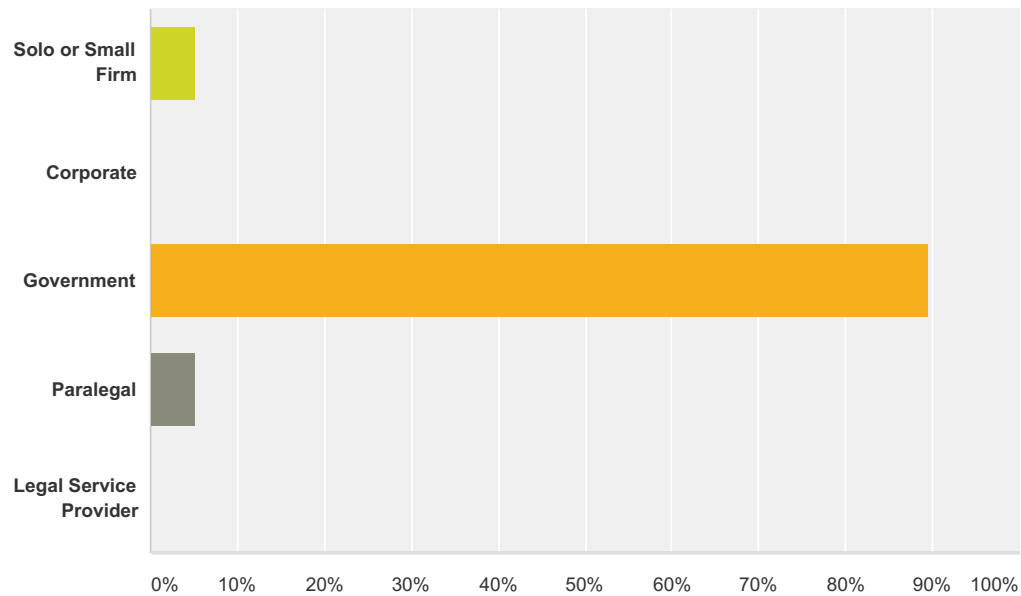

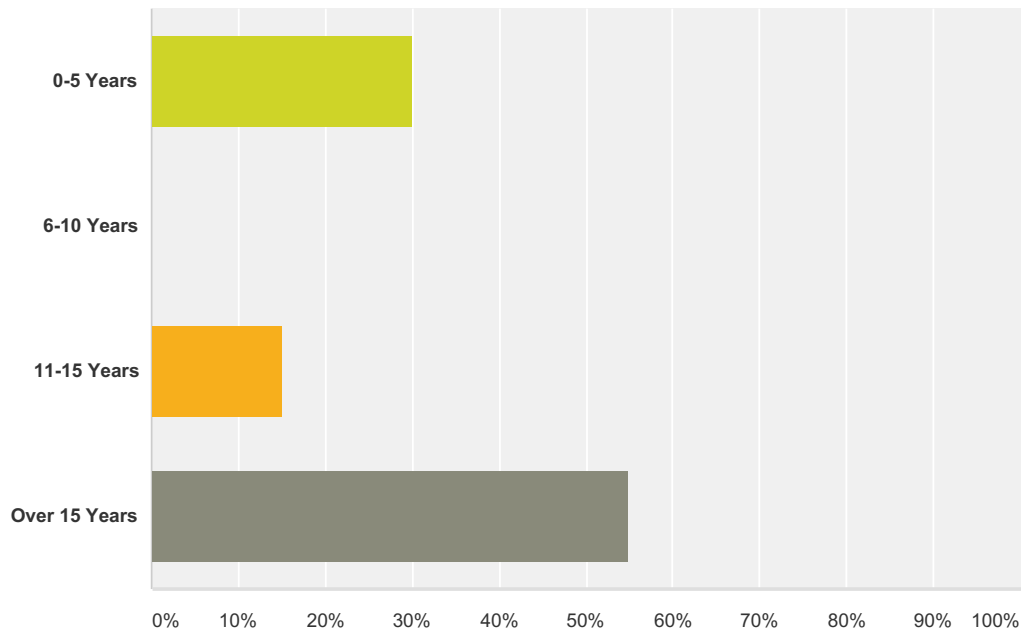

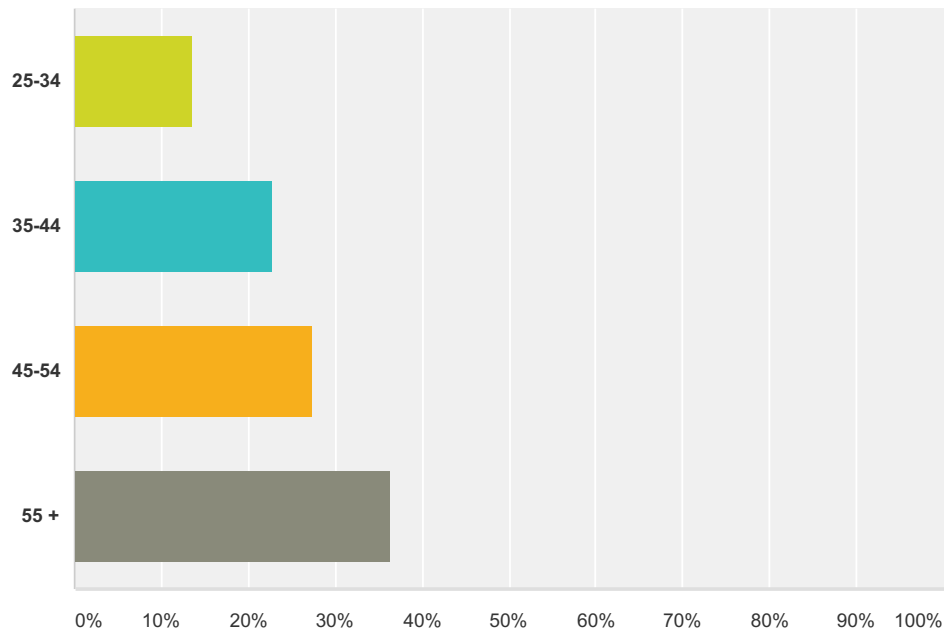
