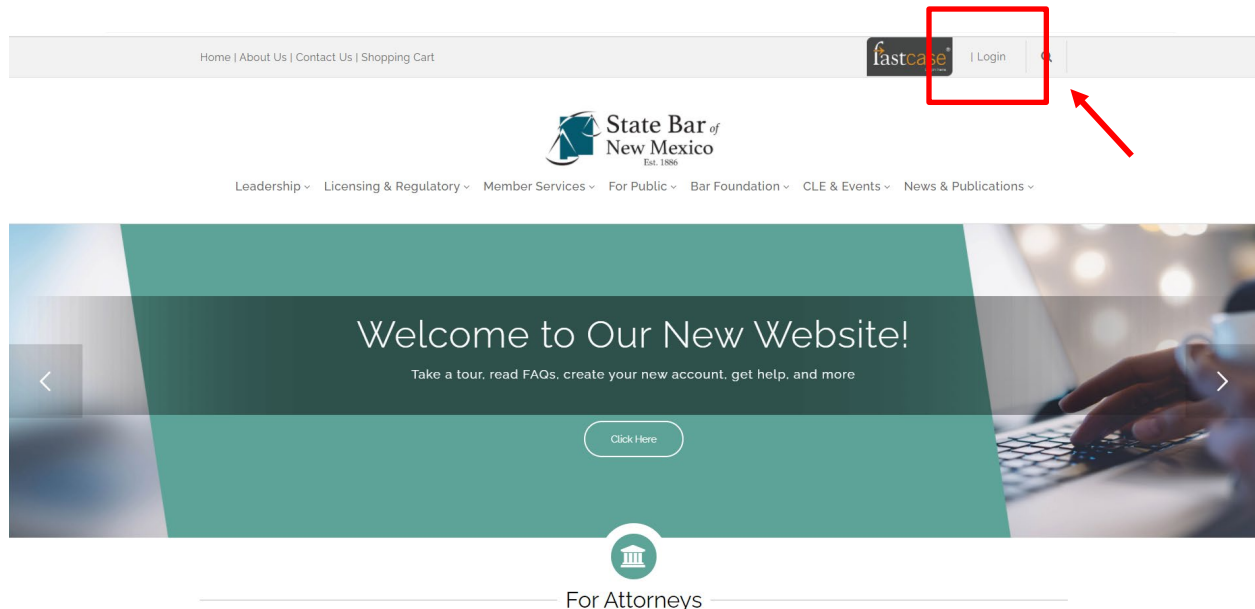




Password Reset Instructions

If it is your first time logging in to the new website or you have forgotten your password, you will need to reset your account.

Visit www.sbnm.org and click **LOG IN** in the top right hand corner




Only licensed members of the State Bar (attorneys, judges, etc.), are able to login. If you are a member of the public, content directed at you can be accessed under the “FOR PUBLIC” tab without any login restrictions.

Your Username will be your EMAIL OF RECORD

To check your email of record, look yourself up in the [ONLINE MEMBER DIRECTORY](#).


If you already know that you do not have access to your most recent email of record, please email techsupport@sbnm.org. Your email address will need to be changed in our system before you can log in.

Click FORGOT PASSWORD

Type in your email address of record. And click SEND LOGIN INFORMATION.

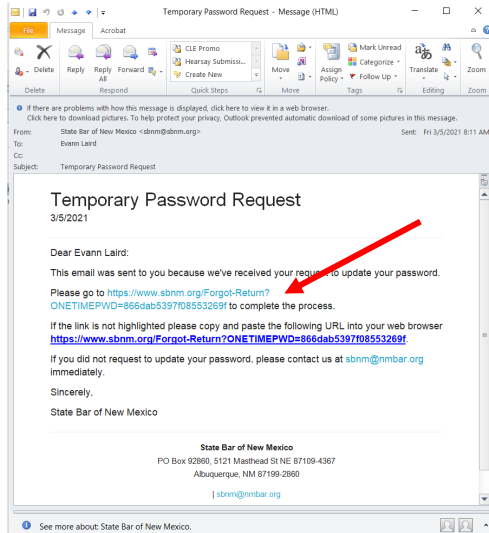

Open up your email and look for an email from the State Bar titled TEMPORARY PASSWORD REQUEST. You may need to check your junk or clutter folder.

Click the link to reset your password.



It will redirect you to the State Bar website's password change form.

Do not change anything in the TEMPORARY PASSWORD field.

Under USERNAME, enter your EMAIL OF RECORD (the email to which the password reset was sent).

Enter a secure password in NEW PASSWORD.

Type in the same password in CONFIRM NEW PASSWORD.

Click UPDATE MY PASSWORD.
