

# **Administrative Office** of the Courts **Notice of New Criminal Competency Case Types**

https://lawlibrary.nmcourts.gov.

The New Mexico Judiciary is announcing the planned Jan. 1, 2026, rollout of new criminal competency case types and statewide standard operating procedures for processing competency cases, including the below additions:

- The old "Lower Court Competency" (SI) civil case type will be disabled (although existing LCCSI cases will remain available to process).
- Two new criminal competency case types will be available for all District courts:
  - o Competency Felony (FI).
  - o Competency Misdemeanor (MI).
- The FI and MI case types will:
  - o Not be automatically sealed, although specific documents and pleadings within the case will remain sealed, and a judge may still order the sealing of a case.
  - o Be related to the underlying case.
  - o Be available for subsequent e-filing through File & Serve, unless a judge's order has sealed the case.

# **Professionalism Tip**

With respect to the public and to other persons involved in the legal system:

I will strive to set a high standard of professional conduct for others to follow.

- o Be available online as a Tier 1 criminal case in re:SearchNM and Case Lookup.
  - Those continuing to use Secured Odvssev Public Access (SOPA) will not be able to access these FI and MI cases. Please contact support@nmcourts.gov if you have any questions about a re:SearchNM account.

At this time, all other proceedings for competency evaluations and restoration activities will remain the same.

The Board of Bar Commissioners of the State Bar of New Mexico met on October 24 at the State Bar Center in Albuquerque, N.M. Action taken at the meeting follows:

- Approved the July 31, 2025 Meeting Minutes:
- Began review and discussion of Rule 24-101(A) NMRA, Rules Governing the NM Bar, Objective #6, Encourage and Assist in the Delivery of Legal Services to all in need of those services, and will continue discussion at the December meeting;
- Reported that the Strategic Plan Committee reviewed the 2026-2028 Strategic Plan and will be meeting again in November to finalize it for the Board's approval at the December meeting;
- Held an executive session to discuss a personnel item;
- Elected Commissioner Lucy H. Sinkular as President-Elect and Commissioner Tomas Garcia as Secretary-Treasurer by acclamation for 2026;
- Received the service and independent contractor agreements for the State Bar and approved the agreements and referred the contracts policy to the Policy and Bylaws Committee for review;
- Approved the 2026 State Bar Budget;
- Appointed Chelsey Pelzman to the Access to Justice Fund Grant Commission for a three-year term;
- Approved a request from the Federalist Society to become an accredited CLE provider;

- · Received a report from the Executive Committee and ratified the action taken by the committee, which included approval of a sponsorship request in the amount of \$1,000 for the NM Women's Bar Association Annual Henrietta Pettijohn Awards Reception;
- Accepted the July and August 2025 Financials;
- Received a report from the Policy and Bylaws Committee and approved two recommendations to propose to the Supreme Court: 1) for the Board to have a voting member on the Board of Bar Examiners who would also serve as the liaison, and 2) allow the liaisons to all of the Supreme Court Committees and Boards to participate in meetings and be included in all discussions, be permitted to vote, and to report back to the board as appropriate, subject to confidentiality;
- Received a presentation on the Supreme Court's Alternative Pathways Commit-

**Health:** We often think of health as purely physical, yet social and organizational health are equally essential to our wellbeing and longevity. Over the past year, we have worked to strengthen the health of the State Bar of New Mexico. 2025 was a unique year, situated between the conclusion of the 2023–2025 Three-Year Strategic Plan and the creation of the 2026–2028 Plan. From 2023 to 2025, I witnessed tremendous growth through initiatives such as the distribution of published Court of Appeals opinions, the continued independence and expansion of the New Mexico State Bar Foundation and the reimagining of our Annual Meeting.

In keeping with our "Together Towards Justice" theme, this year's Annual Meeting was a powerful expression of the challenges faced by the legal profession, as well as the ways we can come together to overcome them.

# H Year-End Note on Pro Bono in New Mexico by Supreme Court Tustice C. Shannon Bacon



Dear Colleagues,

As the holidays approach, I am reminded of the needs of everyday New Mexicans who do not have the fortune that most of us do. In 2025, there are nearly 3,000 unhoused people in Albuquerque, over 300,000 New Mexicans face food insecurity and almost 20% of New Mexicans live below the poverty guidelines.

With these financial challenges, it is no wonder that a large percentage of New Mexicans cannot afford legal representation. Three out of four low-income households in New Mexico struggle with legal issues that impact housing, financial stability and access to social and medical benefits.

Adding to these pressures, the Federal House Appropriations Committee has recommended cutting the funding for the Legal Services Corporation (which in turn funds New Mexico Legal Aid, DNA People's Legal Services and the like) by an astonishing 46%. This would return funding levels for critical legal services for low-income New Mexicans to those available in 1999.

So, what can we, the members of the State Bar of New Mexico, do? We can serve, volunteer and give.

Rule 24-108 NMRA encourages 50 hours of pro bono public legal services per year or a \$500 financial contribution to organizations that provide legal services to low income New Mexicans.



# Ask-a-Lawyer Call in Day




# The New Mexico Attorney In Memoriam Ceremony & Attorney Memorial Scholarship:

# The In Memoriam Ceremony: Sentimental Beginnings

Terrence ("Terry") Revo, a retired attorney who previously practiced as an attorney for Second Judicial District Attorney Ira Robinson and whose practice included work in personal injury and real estate, spoke of Brad's legacy: "[He] probably had more social [and] personal contacts than most people," Terry stated. "And I'm sure he was the one who said, 'We need to honor these guys." Having passed away on April 1, 2023, Brad's legacy lives on through the In Memoriam ceremony, held each year at the State Bar Center in Albuquerque, N.M.

# A Gathering for Respect and Reflection

The Senior Lawyers Division's goals are primarily to "improve the administration of justice, to promote the interests of the legal profession in the State of New Mexico, and to promote and support the needs of all members," have developed a steady and stable process for preparing the ceremony itself. "I don't think the event has changed an awful lot," Terry elaborated. "The process of the event is still pretty much the same." For the most part, the ceremony is coordinated by the Chair of the Attorney Memorial Scholarship Committee ("the Committee").

Terry confirmed that organizing the event does not present overwhelming challenges, and that the Chair conducts the majority of the setup through collaboration with other members of the Attorney Memorial Scholarship Committee and Senior Lawyers Division Board of Directors. 2025's Senior Lawyers Division Board of Directors have included Jocelyn M. Torres (Chair), Peter Chestnut (Chair-Elect), Daniel J. Behles (Secretary-

Treasurer and BBC Delegate). Other Directors include Kari Brandenburg, Richard Kraft, Hon. Freddy Romero, Hon. Michael Bustamante, Deborah Seligman, Kathryn Rubi, Terry and Charles Gurd.

Once the preparation is complete, members of New Mexico's legal community and relatives of the deceased attorneys and judges honored during the ceremony gather at the State Bar Center. The Committee members provide heartfelt remarks at the beginning of the ceremony to set a reflective and warm tone that give weight to the event's purpose. A Committee member then cites the names of each attorney, judge and legal professional who passed away over the last year as provided to the Senior Lawyers Division over the course of a presentation that includes pictures of the deceased.

# A Consistent Process and an Expression of Gratitude

The In Memoriam ceremony has evolved in small ways, including the addition of a gong. After the announcement of each of the honorees' names, a Committee member will use a brass singing bowl as a gong for effect. Terry's assessment is that the process of planning the ceremony is effective, despite one particularly difficult challenge in reaching the families of those that have been lost. That challenge is one the Committee encounters each year, Terry notes. In an era where legal practice has become dispersed and attorneys move states or retire from public view, reaching relatives can be unexpectedly difficult. Nevertheless, the Committee continues pursuing every lead because, as Terry emphasizes, having families present completes the ceremony.

More than that, the ceremony is a tribute to the perseverance and grit to members now in the loving memory of New Mexico's tightly knit legal community.

"These attorneys gave their lifeblood and their energy to the practice of law for the benefit of the legal community," Terry says with passion. "The legal community has a responsibility to [act on] it – to say 'thank you' in some way."

As deceased members of the legal community endured the challenges associated with the profession, "the families lived through all of that," Terry firmly states. "So really, the event is a 'thank-you' to the attorneys and to the families. That's what it stands for."

As the ceremony honors the members of the community's past, it simultaneously recognizes and elevates its future through the Attorney Memorial Scholarship.

# Bridging a Generational Gap

Each In Memoriam ceremony is followed directly by a presentation of the Attorney Memorial Scholarship to three distinguished third-year (3L) law students. After 500-word essays

covering a topic created by the Attorney Memorial Scholarship Committee are submitted by law students at the UNM School of Law, law school administrators will remove all "identifying characteristic[s]," confirms Terry, to ensure anonymity among the students. The committee will then deliberate on the quality of each essay and eventually decide on three winners to receive the scholarship in the amount of \$5,000.

This process is strongly supported by UNM School of Law staff including Serge Martinez, an Associate Dean and Professor at the UNM School of Law, who runs the law school's Economic Justice Clinic. Joining the State Bar of New Mexico in 2016, Serge acknowledges he is relatively new to New Mexico's legal community. Having recently become a member of the Senior Lawyers Division, Serge points out the warmth and closeness of New Mexico's legal community.

"This is a relatively small community where you see the same people in the courthouse," Serge notices. "You know who you're going to be dealing with. There's a sense of, 'We're all here together."

His ties to the Senior Lawyers Division's In Memoriam ceremony and Attorney Memorial Scholarship begin with his experience leading the Economic Justice Clinic. Teaching half of the 3L law students at UNM School of Law each year, his introduction to the In Memoriam ceremony "came when members of the Senior Lawyers Division reached out and asked if they could talk to my students about the scholarship. Since I tend to teach half the thirdyear class each year, that seemed like a natural audience."

Serge says that, when the Senior Lawyers Division members, including Terry and Jocelyn, come to speak to his class, the students "get to see that they're part of a larger profession they're joining. It's not just the law school - it's the whole legal community."

# A Broader Celebration of the Past, Present and Future

As the In Memoriam ceremony reflects on the past members of New Mexico's legal community, the presentation of the Attorney Memorial Scholarship is forward-looking and uplifting.

"[The law students] see that this community cares about them, and they're part of something with history," Terry says of the full event's perspective of continuity. "They're going to be the ones carrying that forward."

"They're entering a profession with history and people who've come before them," Serge iterates. "The ceremony shows that you're part of something bigger. You're part of this lineage, this community that stretches back decades. You're the newest brick in a wall built by the people before you."

# These Values We Cherish

Although law practice has changed in the modern era, the spirit that holds the legal community together remains strong and intact. While Terry notes that law practice now entails more responsibilities and that the community isn't as connected as it once was, the In Memoriam ceremony is nonetheless a timeless tradition celebrating the values of community and connection that underpin the foundation of New Mexico's population of legal professionals.



"The practice of law is tougher and the responsibilities are greater," Terry frankly states.

Nevertheless, the In Memoriam ceremony and Attorney Memorial Scholarship are intrinsically values-based through its roots in the legal profession. Terry emphasizes the importance of professionalism and reputation in the legal field, which he says "is what follows you."

As an example of these two pillars of excellence in the legal field, Serge discusses one of his role models, Justice Pamela B. Minzner, as an "ideal combination of professionalism, humanity and compassion." As a tribute to her demonstration of these values, the State Bar of New Mexico's Annual Awards include the Justice Pamela B. Minzner Award, which "recognizes attorneys and/or judges who, over long and distinguished legal careers, have by their ethical and personal conduct exemplified for their fellow attorneys the epitome of professionalism." Both Terry and Serge's sentiments highlight professionalism's significance as a bedrock for legal professionals joining and being a part of New Mexico's legal community as built by the hard-working and resilient members of that community's past.

The values that bind the community are not abstract to New Mexico's legal professionals. They are also lived and revered across generations, from the attorneys honored in the ceremony to the students stepping forward through the scholarship.

# A Timeless Tradition of Memory, Honor and Community

The Senior Lawyers Division's In Memoriam ceremony and Attorney Memorial Scholarship Presentation, on its surface, commemorates the legacy of the legal professionals of New Mexico's past while importantly tilting its hat to the makeup of the profession's future. Connected by values of respect, professionalism and responsibility, the legal community and families of those in the legal community are offered a nostalgic and sentimental opportunity through the In Memoriam ceremony and Attorney Scholarship Presentation to remember the very legal professionals who shaped the community into what it is today.

# The I2<sup>th</sup> Annual New Mexico Attorney In Memoriam & 2025 Attorney Memorial Scholarship Presentation

n Nov. 18, 2025, the State Bar of New Mexico Senior Lawyers Division ("Senior Lawyers Division") held their annual New Mexico Attorney In Memoriam ceremony at the State Bar Center. Many members of New Mexico's legal community, including State Bar President Aja N. Brooks, as well as relatives of those who were recognized during the In Memoriam ceremony, attended the event to honor members of New Mexico's legal community who passed away during the past year.

The New Mexico Attorney In Memoriam ceremony's speakers included Senior Lawyers Division Chair Jocelyn Torres and fellow Board members Peter Chestnut and Terrance ("Terry") Revo, as well as University of New Mexico School of Law Associate Dean Serge Martinez. 

# with Chrystian J. Gonzalez, Esq.



The mission of the State Bar of New Mexico's Equity in Justice Program is to cultivate and grow a legal profession in New Mexico that is representative of and reflective of the people of New Mexico. As part of that mission, we bring you the series "Inclusive Interviews." We call these inclusive interviews both as a play on words and as a contrast to the term "Exclusive Interview."

Because legal employers with inclusive hiring and employment practices have a bigger talent pool from which to hire and access to a larger client base, these interviews serve to amplify that growing and cultivating inclusivity and belonging in our profession is beneficial to all legal employers; be they private firms, government entities or nonprofits.

This Inclusive Interview is with Chrystian J. Gonzalez, Esq. Chrystian has been practicing law for five years and is a Children's Court Attorney for the New Mexico Children, Youth, and Families Department. He also currently serves as a Bar Commissioner for the 3rd and 6th Judicial Districts on the State Bar of New Mexico Board of Bar Commissioners.

#### **Q:** What is your background?

A: I am a first generation Mexican American, born in El Paso, Texas. My parents are originally from El Paso's sister city, Ciudad Juarez, Chihuahua, Mexico. I am also a veteran of the United States Air Force, where I served as an active-duty enlisted member for six years, earning the rank of Staff Sergeant. During my service, I trained and supervised incoming airmen and participated in deployments supporting pre and post-9/11 missions, such as Operations Northern Watch, Enduring Freedom, and Iraqi Freedom.

## Q: What made you want to become a lawyer?

A: The idea of pursuing a career as an attorney had not occurred to me until one of my college philosophy professors talked to me about law school and becoming an attorney. Had he not planted this seed of possibility, I might not have considered it an achievable path. But my curiosity and desire for success motivated me to try; so, I went for it. And that meeting having made all the difference, I now try to plant the same seed every chance I get. While I have always been drawn to serving my community, I am beyond captivated with the combination of analytical thinking with advocacy, and with using knowledge to empower others and create fairness out of a legal dispute.

# Q: What has been your greatest accomplishment in your legal career or of what in your legal career are you the most proud?

**A:** To put it simply, I am most proud of reaching my clients' goals in a case. The most satisfying moment for me as an attorney is when a judge grants the final order, my client and I share a final handshake, and the case is successfully concluded. Helping a client finalize a legal process that has caused them significant stress truly brings profound fulfillment.



# Q: What has been the biggest challenge you have had in your legal career?

A: My biggest challenges come from my current position as a Children's Court Attorney. Collaborating with social workers and investigators to assess a family's situation can be heartbreaking when we find that legal limitations prevent us from assisting them. The law tends to be reactive rather than proactive by design, which is usually quite effective, but also disappointing when it fails, especially in cases of abuse or neglect of children.

# Q: What is your favorite part of your current position?

A: Dismissing a case, particularly when children are reunified with their parents, is a joyous occasion in the courtroom that everyone that is present cannot help but celebrate. Also, completing a child or sibling adoption, especially when they have been waiting a long time to finalize. It is wonderful to witness these moments.

# Q: What is your advice for other veterans who want to become lawyers?

A: If any fellow veteran is considering this path, I would assume that they may feel as I did: unprepared for new territory and doubting the probabilities of success. The Air Force had three tenets that I still hold to: integrity first, service before self, and excellence in all we do. These are ingrained as we set out to learn the many useful skills needed to thrive in the military, from hospital corners to strategic thinking, and experiences in a world much bigger than the one we came from. In my experience, many people join the military because they want to be a part of something bigger, and because they want to make something of themselves. I believe I was better prepared as a veteran than I ever would have been as a recent graduate. Joining the legal community is no different. What's more, the fundamental rules are the same, except the armory is in the law books and the fight is the courtroom. So, I would encourage others to just go for it and not look back.

# Q: If you could have one superpower, what would it be, and why?

A: The Flash, of course! If every time I were headed to Court, I could familiarize myself with the entire Code, relevant caselaw, pleadings, and evidence in a matter of seconds, I would be unstoppable. But it also wouldn't hurt to have Barry Allen's metabolism and enjoy seconds and even dessert after every meal.

## Q: What is something the legal profession in New Mexico can do to be more inclusive?

A: I think the New Mexico Bar is actively advancing inclusivity consciously and continuously. This very project is creating space and opportunities for veterans, and other individuals from diverse backgrounds, to feel more welcomed and supported within the legal profession. Still, there is always more that can be done. One meaningful way the legal community can become even more inclusive is by expanding outreach and support for aspiring legal professionals from rural, Indigenous, and Hispanic communities. These groups represent a significant portion of our state's population yet remain underrepresented in the legal field. I believe that nothing is more important than this effort and taking active steps to make these goals a reality creates a legal profession that would better serve both its members and its community

As an immigration lawyer, he devoted his life to helping immigrants make their homes here in the United States because he understood that our country is stronger because of their contributions. John was a talented trumpet player and passed on his love of music, history, and politics to his daughters. John is survived by his daughter Sonia Russo and her husband Don McGinnis, his daughter Shawna Russo, his grandson Charlie Vidmar, and his siblings Nancy (Frank), Carmine (Jackie), Al, and Emmerson and their children. John was preceded in death by his parents Lily and Carmine Russo.

Frank Murray III was born in El Paso, Texas but grew up entirely in Clovis, New Mexico with a two year younger brother, George, to parents Frank and Velma Murray. As a master attorney for the state, he also held the position of counsel for the NM National Guard and ended his career working with Child Support Enforcement. After retirement, he became a bill analyzer for the NM Legislature until the cancer, he fought courageously for 16 years, left him unable to do so. #### **OPINION**

#### THOMSON, Chief Justice.

{1} "[A] valid release or exoneration of the servant releases the master." *Downer* v. S. *Union Gas Co.*, 1949-NMSC-045, ¶ 7, 53 N.M. 354, 208 P.2d 815. We articulate this rule as the Extinguishment Rule, a means to cut the vicarious liability of

principals off at its source: the agent. Liana Trujillo (Plaintiff) asks this Court to reverse the Court of Appeals and district court's conclusion that her vicarious liability claims against Presbyterian Healthcare Services, Inc. (Presbyterian) were extinguished when she stipulated to the dismissal with prejudice of several of the treating radiologists (the Radiologists).

{2} In this opinion, we hold that vicarious liability claims are only extinguished through (1) a release of claims arising out of an agent's conduct or (2) the exoneration of an agent through a disposition on the merits. Because the stipulated dismissal with prejudice in this case served as neither, we reverse the district court and Court of Appeals and remand for reinstatement of Plaintiff's vicarious liability claims against Presbyterian.1 In clarifying the requirements of the extinguishment rule, we overrule Kinetics, Inc. v. El Paso Products Co., 1982-NMCA-160, 99 N.M. 22, 653 P.2d 522, in so far as it treated a dismissal with prejudice as a release.

#### I. BACKGROUND AND P ROCEDURAL HISTORY

{3} Severo Ortega died of pneumonia while in Presbyterian's care. Following his death, Plaintiff, Mr. Ortega's daughter, sought and obtained appointment as the personal representative of Mr. Ortega's wrongful death estate under the Wrongful Death Act, NMSA 1978, §§ 41-2-1 to -4 (1882, as amended through 2001). Plaintiff then brought, on behalf of herself and as the personal representative of Mr. Ortega's wrongful death estate, direct negligence claims against Presbyterian and the physicians who treated Mr. Ortega, as well as vicarious liability claims against Presbyterian, alleging that those treating physicians were acting as Presbyterian's agents. {4} Several of the alleged agents who treated Mr. Ortega were radiologists.

treated Mr. Ortega were radiologists. One of the radiologists, James J. Montesinos, M.D., sought to stay the case as required by the New Mexico Medical Malpractice Act until the New Mexico Medical Review Commission reviewed the matter and rendered a decision. *See* NMSA 1978, § 41-5-15 (1976). Plaintiff did not oppose the motion, and the district court entered a stipulated order staying the case pending the panel's decision.

Plaintiff also raised statutory arguments and challenged the district court's conclusion that her motion for reconsideration of the stipulated dismissal was deficient. Because reversing the district court's grant of summary judgment eliminates the need to address those issues, we decline to do so.

#### From the New Mexico Supreme Court

{5} Roughly three months into the stay, the district court entered a stipulated order dismissing the Radiologists from the case and lifting the stay. The stipulated order provided:

This matter having come before the [c]ourt upon stipulation of the parties: Plaintiff, Liana Trujillo, individually and as the Personal Representative of the Wrongful Death Estate of Severo Ortega . . . and the Defendants, James J. Montesinos, M.D., Samuel Southam, M.D., and Eugenio Rivera, Jr., M.D. . . . pursuant to Rule 1-041 NMRA, hereby stipulate to a dismissal of James J. Montesinos, M.D., Samuel Southam, M.D., and Eugenio Rivera, Jr., M.D. The [c] ourt, having reviewed the parties' stipulation and being otherwise apprised of the matters, finds:

- 1. James J. Montesinos, M.D., Samuel Southam, M.D., and Eugenio Rivera, Jr., M.D. are hereby dismissed from this action with prejudice.
- 2. Each party shall bear its own attorney's fees and costs.
- 3. The stay of proceedings entered December 13, 2018 is hereby lifted.

(Emphasis added.)

{6} The "parties' stipulation" referenced in the order was not docketed, suggesting that the stipulated order was a proposed order. This is also indicated by the fact that the stipulated order included an additional signature block titled "Submitted and Approved By" below the district court judge's

signature. Counsel for both Plaintiff and the Radiologists signed the stipulated order. {7} Plaintiff, through her new counsel, moved for partial summary judgment on Presbyterian's vicarious liability for the alleged negligence of Dr. Montesinos, one of the Radiologists dismissed in the stipulated order with prejudice. In her motion, Plaintiff requested a determination as a matter of law that Presbyterian would be vicariously liable for Dr. Montesinos' conduct. Plaintiff argued that dismissing her direct claims against Dr. Montesinos "does not affect Plaintiff's vicarious liability claims against [Presbyterian]. Unless there is an explicit release or dismissal of Plaintiff's vicarious liability claims . . . [those claims] should stand." The district court denied the motion, finding genuine issues of material fact and stating that the question of vicarious liability was "going to go to the jury."

- {8} Presbyterian then sought summary judgment on the same issue, arguing that Plaintiff dismissing Dr. Montesinos—Presbyterian's alleged agent—with prejudice had, in fact, extinguished her vicarious liability claims. In response, Plaintiff maintained that, absent a release of the Radiologists, her claims were not extinguished.2 The district court granted Presbyterian's motion, reasoning that "Plaintiff dismissed the radiology defendants from this case with prejudice . . . and therefore, vicarious liability claims against [Presbyterian] for the radiologists' negligence premised on an agency theory were extinguished as a matter of law."
- {9} Following the district court's denial of a motion for reconsideration regarding its summary judgment orders and stipu-

lated order dismissing the Radiologists,<sup>3</sup> Plaintiff dismissed her remaining claims without prejudice and appealed. The Court of Appeals affirmed, concluding that by dismissing the Radiologists with prejudice, Plaintiff also "extinguishe[d] the derivative claim against [Presbyterian]." *Trujillo v. Presbyterian Healthcare Servs., Inc.*, 2024-NMCA-004, ¶ 15, 539 P.3d 1216 (quoting *Valdez v. R-Way, LLC*, 2010-NMCA-068, ¶ 14, 148 N.M. 477, 237 P.3d 1289). <sup>4</sup>

#### II. DISCUSSION

#### A. Standard of Review

{10} The Court reviews orders granting or denying summary judgment and the legal question of whether a dismissal with prejudice may serve as a release de novo. *Zamora v. St. Vincent Hosp.*, 2014-NMSC-035, ¶ 9, 335 P.3d 1243.

#### B. The Extinguishment Rule Does Not Bar Plaintiff's Vicarious Liability Claims Against Presbyterian

{11} The Court of Appeals erred in concluding that voluntarily dismissing an agent with prejudice extinguishes vicarious liability claims against the principal absent an underlying release. While such a dismissal may bar claims against the agent, it does not go to the source of a principal's liability in vicarious liability: the agent's tortious conduct. To clarify that key distinction and provide guidance on the proper application of the Extinguishment Rule, this opinion first lays out the core principles underlying vicarious liability and the Extinguishment Rule. It then situates a stipulated dismissal with prejudice within the Extinguishment Rule.

<sup>&</sup>lt;sup>3</sup> In her motion for reconsideration, Plaintiff included a request for the district court to reverse the stipulated order dismissing with prejudice the Radiologists, the denial of which she appealed in the Court of Appeals and in this Court. Because we conclude that the stipulated dismissal did not extinguish Plaintiff's vicarious liability claims, there is no need to reverse the stipulated dismissal for those claims to proceed.

In a special concurrence, Judge Bustamante observed that the Extinguishment Rule has "strayed beyond its doctrinal roots," creating a web of procedural traps for tort claimants. Trujillo, 2024-NMCA-004, ¶ 31 (Bustamante, J., specially concurring). To correct course, he suggested adopting a rule limiting extinguishment to circumstances in which the claims against the agent are adjudicated on their merits. Id. ¶ 32 (citing Laurence v. Salt River Project Agric. Improvement & Power Dist., 255 Ariz. 95, 528 P.3d 139, 141 (2023)). This Court need not reach Judge Bustamante's suggestion because the law in New Mexico is actually quite clear: a voluntary dismissal with prejudice is not a release and does not extinguish vicarious liability claims.

#### From the New Mexico Supreme Court

#### 1. Vicarious liability

{12} Vicarious liability is a common-law theory of liability rooted in agency through which a principal may be held liable for their agent's tortious conduct. See\_Monett v. Dona Ana Cnty. Sheriff's Posse, 1992-NMCA-096, ¶ 10, 114 N.M. 452, 840 P.2d 599 ("Under the doctrine of respondeat superior, the master is liable for the negligent acts of the servant when committed during the course and scope of the servant's employment or agency."); see also Baer v. Regents of Univ. of Cal., 1994-NMCA-124, ¶ 18, 118 N.M. 685, 884 P.2d 841 ("The law in New Mexico is well settled that, under the doctrine of respondeat superior, an employer can be held vicariously liable for the negligent acts of an employee when committed during the course and scope of the employee's employment."). There are multiple avenues for establishing vicarious liability, but all routes (1) depend on an agency relationship between the principal and the tortfeasor and (2) impute liability to the principal for the agent's tortious conduct. See Spurlock v. Townes, 2016-NMSC-014, ¶ 14, 368 P.3d 1213 (comparing traditional principles of respondeat superior with an aided-inagency theory for establishing vicarious liability).

{13} Here, Plaintiff has alleged that the Radiologists were Presbyterian's apparent agents. Under that theory, Plaintiff may establish an agency relationship even though Presbyterian did not employ the Radiologists by demonstrating Presbyterian held the Radiologists out as its agents by allowing them to provide care in the hospital and that there was reasonable reliance on that representation. See Houghland v. Grant, 1995-NMCA-005, ¶ 22, 119 N.M. 422, 891 P.2d 563 (finding apparent agency where independent physicians provide services in a hospital emergency department, reasoning that "[w]hen members of the public seek care at a modern hospital emergency room, they reasonably assume that the hospital is responsible for their care"); see also Zamora, 2014-NMSC-035, ¶ 18 ("[A] malpractice claim arising from care in a hospital emergency room implicates the hospital in the actions of any employees or agents-known or unknown to the plaintiff—who took part in that care."). Because

of that apparent agency relationship, Plaintiff argues, Presbyterian is vicariously liable for the Radiologists' negligence during Mr. Ortega's emergency care.

#### 2. The Extinguishment Rule

{14} The Extinguishment Rule provides that one cannot hold the principal vicariously liable if the agent was not negligent or where there exists a valid release of claims arising from the agent's conduct. Both "extinguish" the principal's liability. Absent exoneration or release, however, the Extinguishment Rule does not apply and the principal remains vicariously liable for the agent's malfeasance. Downer, 1949-NMSC-045, ¶ 7 ("The escape of [the principal], however, is predicated upon the existence of a valid and subsisting release of the [agent]."); see also Harrison v. Lucero, 1974-NMCA-085, ¶ 12, 86 N.M. 581, 525 P.2d 941 ("[A]bsent any delict of the master other than through the servant, the exoneration of the servant removes the foundation upon which to impute negligence to the master." (internal quotation marks and citation omitted)).

{15} Neither predicate for extinguishing Plaintiff's vicarious liability claims is present in this case. Plaintiff's vicarious liability claims were disposed of in a summary judgment order which concluded, without citation, that the stipulated dismissal with prejudice of the Radiologists extinguished Plaintiff's vicarious liability claims against Presbyterian "as a matter of law." That can only be true, however, if the stipulated dismissal itself served as either an adjudication on the merits, such that it exonerated the Radiologists, or a valid release. We conclude that the stipulated order dismissing the Radiologists with prejudice acted as neither and, therefore, did not extinguish Plaintiff's vicarious liability claims.

#### a. A voluntary dismissal with prejudice does not serve as exoneration

{16} "Exoneration" for purposes of extinguishment is commonly understood as requiring adjudication of the agent's tortious conduct on the merits. Juarez v. Nelson, 2003-NMCA-011, ¶ 28, 133 N.M. 168, 61 P.3d 877 (surveying other jurisdictions' application of the term "exoneration" in the context of extinguishment), overruled https://www.nmcompcomm.us

on other grounds by Tomlinson v. George, 2005-NMSC-020, ¶ 18, 138 N.M. 34, 116 P.3d 105. Here, the voluntary dismissal with prejudice did not address the merits of Petitioner's negligence claims against the Radiologists, and, by itself, the order does not serve as an adjudication on the merits. {17} In New Mexico, a dismissal with prejudice is only an adjudication on the merits for purposes of res judicata. Kirby v. Guardian Life Ins. Co. of Am., 2010-NMSC-014, ¶ 66, 148 N.M. 106, 231 P.3d 87 ("A dismissal with prejudice is an adjudication on the merits only to the extent that when a claim has been dismissed with prejudice, the fourth element of res judicata (a final valid judgment on the merits) will be presumed so as to bar a subsequent suit against the same defendant by the same plaintiff based on the same transaction."). Thus, while the voluntary dismissal with prejudice precludes Plaintiff from bringing negligence claims against the Radiologists arising from their treatment of Mr. Ortega, it did not determine the merits of the negligence claims or exonerate the Radiologists, and thereby extinguish Plaintiff's vicarious liability claims.

#### b. A voluntary dismissal with prejudice is not a release

{18} New Mexico law is clear that "[r] eleases are contractual in nature and thus are governed by traditional principles of contract law." McNeill v. Rice Eng'g & Operating, Inc., 2003-NMCA-078, ¶ 13, 133 N.M. 804, 70 P.3d 794; see also Perea v. Snyder, 1994-NMCA-064, ¶ 20, 117 N.M. 774, 877 P.2d 58 ("Releases, because they are contractual in nature, are governed by the laws of contract."), overruled on other grounds by Spectron Dev. Laby v. Am. Hollow Boring Co., 1997-NMCA-025, ¶ 31, 123 N.M. 170, 936 P.2d 852; Restatement (Second) of Torts § 900 cmt. b (Am. Law Inst. 1979) (defining a release as "a writing either under seal or supported by consideration, stating that the claim against the tortfeasor is discharged" and directing the reader to the Restatement (Second) of Contracts for additional information on releases). In Downer, the case that first articulated the Extinguishment Rule in New Mexico, the core issue was the validity of the underlying release. 1949-NMSC-045, ¶ 7. The Downer Court

applied traditional concepts of contract formation to conclude that "if the release is invalid because of mutual mistake, fraud, etc. it is not available as a defense to either the master or the servant." *Id.* § 8 (citation omitted). Clear is the requirement of "a valid release" for the master to be relieved of the servant's liability. *Id.* § 7.

{19} Here, it is undisputed that Plaintiff did not sign a release. There is no contract that arguably extinguished Plaintiff's vicarious liability claims. Nor does the stipulated dismissal order itself include any release language or language dismissing claims.

{20} Instead, Presbyterian argues that a voluntary dismissal with prejudice acts as a release not because the order serves as a contract but because it involves a voluntary relinquishment of claims against the Radiologists and is, therefore, tantamount to a release. The Court of Appeals adopted Presbyterian's reasoning and concluded that "[b]y permanently barring any claim she might have against Dr. Montesinos, Plaintiff not only relinquished her negligence cause of action against him but additionally 'extinguishe[d] the derivative claim against Presbyterian." Trujillo, 2024-NMCA-004, ¶ 15 (quoting *Valdez*, 2010-NMCA-068, ¶ 14). That conclusion is flawed for two reasons: first, it is premised on a misreading of the case law and second, it misunderstands the source of liability in vicarious liability

{21} First, to support its holding, the Court of Appeals relied on language from its opinion in Valdez, which describes releases in exceedingly broad terms. Trujillo, 2024-NMCA-004, ¶ 15 (citing Valdez, 2010-NMCA-068, ¶ 14). In relevant part, Valdez compiled cases from other jurisdictions defining releases, including California law describing a release as an "abandonment, relinquishment or giving up of a right or claim to the person against whom it might have been demanded or enforced . . . and its effect is to extinguish the cause of action," and Idaho law defining a release as "a surrender of the cause of action, which may be gratuitous, or given for inadequate consideration" and "a complete abandonment of the cause of action." *Valdez* 2010-NMCA-068, ¶ 14 (internal quotation marks and citations omitted).

{22} At face value, these descriptions seem to mirror the effect of a voluntary dismissal with prejudice, suggesting that such a dismissal might operate as a release for purposes of extinguishment. However, a closer look reveals that *Valdez* and all of the cases that *Valdez* relies upon to define "release" involved an actual contract effectuating the release at issue. *See id.* So, while the language appears to encompass dismissals with prejudice, once in context, it reinforces the conclusion that a release is, in fact, a creature of contract.

{23} Second, in concluding that the dismissal with prejudice was a release, the Court of Appeals confused the source of liability under a vicarious liability theory. The Court of Appeals concluded that Plaintiff, by forfeiting her right to bring negligence claims against the Radiologists, also forfeited her right to bring vicarious liability claims against Presbyterian based on the Radiologists' conduct. Trujillo, 2024-NMCA-004, ¶¶ 15-16. That is not how vicarious liability operates in New Mexico. {24} Vicarious liability does not hold the principal liable for an agent's adjudicated liability, but rather for the agent's tortious conduct. See Zamora, 2014-NMSC-035, ¶¶ 18, 20 (discussing St. Vincent Hospital as vicariously liable for its agents' actions); see also NMSA 1978, § 41-3A-1(C)(2) (1987) (preserving joint and several liability for "persons whose relationship to each other would make one person vicariously liable for the acts of the other" (emphasis added)). Accordingly, Plaintiff's ability to sue the Radiologists for negligence is immaterial to the question of whether Presbyterian is liable for their conduct based on an agency relationship. Indeed, Plaintiff was never required to name the Radiologists as defendants in her lawsuit or levy direct negligence claims against them in order to bring vicarious liability claims against Presbyterian based on their conduct. See Zamora, 2014-NMSC-035, ¶¶ 14-19 (holding that a complaint adequately https://www.nmcompcomm.us

pled vicarious liability and apparent agency even though it did not recite the theories and the alleged agents were not parties to the case); see also Baer, 1994-NMCA-124, ¶ 20 (rejecting the proposition that vicarious liability claims require joining the alleged agent and explaining that "we know of no authority for the proposition that, in order to prove agency, the agent must be joined as a party to the action"). Nor do Plaintiff's vicarious liability claims against Presbyterian require a determination that the Radiologists themselves were liable—only that their actions were negligent and that they were Presbyterian's agents.

{25} Only one New Mexico Court of Appeals case has treated a dismissal with prejudice as a release: Kinetics, 1982-NMCA-160, ¶ 25. In *Kinetics*, the Court of Appeals, without analyzing the topic or providing any legal support, held that the dismissal with prejudice in that case extinguished the plaintiff's vicarious liability claims. See id. 31. Because *Kinetics* does not provide any support for the proposition that a dismissal with prejudice is a release, and because it stands alone for that proposition in our case law, we overrule Kinetics on that issue and expressly hold that voluntarily dismissing an agent with prejudice, without more, is not a release for purposes of extinguishment.

#### III. CONCLUSION

{26} We hold that the Extinguishment Rule requires either (1) a release of claims arising out of an agent's conduct or (2) the exoneration of an agent through a disposition on the merits. Under that Rule, a stipulated dismissal of the agent is insufficient to extinguish vicarious liability claims. We reverse the district court and Court of Appeals and remand for reinstatement of Plaintiff's vicarious liability claims against Presbyterian.

#### **Introduction of Opinion**

Following a bench trial in metropolitan court, Defendant Ramon Segura was convicted of first offense aggravated driving while under the influence of alcohol (aggravated DWI), contrary to NMSA 1978, Section 66-8-102(D) (3) (2016). For the reasons that follow, we affirm Defendant's conviction.

#### **Introduction of Opinion**

A jury found Defendant P.J. Fitzwater guilty of one count of burglary, contrary to NMSA 1978, Section 30-16-3(B) (1971), and one count of criminal damage to property (over \$1,000), contrary to NMSA 1978, Section 30-15-1 (1963). Defendant appeals, arguing that (1) his convictions violate his right to be free from double jeopardy; (2) the State presented insufficient evidence to support his convictions; (3) the district court committed fundamental instructional error; (4) the district court abused its discretion by denying Defendant's request for a continuance; and (5) Defendant received ineffective assistance of counsel. We affirm.

#### **Introduction of Opinion**

This case returns to our Court after our Supreme Court overturned our memorandum opinion from 2019 wherein we reversed Defendant Jeremiah Gurule's conviction on a speedy trial violation. See State v. Gurule, No. A-1-CA-35724, mem. op. (N.M. Ct. App. July 31, 2019) (nonprecedential), rev'd and remanded, 2025-NMSC-010, 563 P.3d 775. We now address the issues not reached the first time, namely, the voluntariness of Defendant's waiver of his Miranda rights and his ensuing confession, asserted discovery violations, denial of Defendant's requested self-defense jury instruction, and sufficiency of the evidence supporting Defendant's conviction. We affirm the jury verdict.

#### **Introduction of Opinion**

A jury convicted Defendant of (1) possession of a controlled substance, (methamphetamine), contrary to NMSA 1978 Section 30-31-23(A), (E) (2021); and (2) trafficking a controlled substance (fentanyl), contrary to NMSA 1978 Section 30-31-20 (2006). Defendant makes three arguments on appeal. We conclude the following: (1) assuming that the investigating officer provided expert testimony, the foundation for the officer's qualifications was sufficient under the circumstances to avoid plain error and permitting the testimony was not otherwise error: (2) fundamental error did not arise from the State's reference in closing argument to the general intent jury instruction; and (3) the search warrant affidavit established probable cause to search Defendant's residence. We therefore affirm.

On appeal, Defendant alleges that his convictions violate his right to be free from double jeopardy and that the district court erred in admitting certain un-Mirandized statements at trial. For the following reasons, we affirm.
