Steele Secretary The purpose of the New Mexico Client Protection Fund is to promote public confidence in the administration of justice and the integrity of the legal profession by reimbursing losses caused by the dishonest conduct of lawyers in an attorney-client or fiduciary relationship with a claimant. The Fund is administered by nine-member Commission, each of whom is an attorney. Each claim received by Commission is assigned to a Commissioner for investigation and evaluation, resulting a recommendation which is voted on by the full Commission.

COMMISSIONERS

Leigh Anne Chavez Andrew J. Cloutier James T. Reist Matthew C. Sanchez Robert Valdez \$157,917 on 22 claims against 15 lawyers. The previous highest single year of payments from the fund was 2013, with \$117,338 in payments. One claim paid in 2016 arose from a fiduciary relationship; in the other 21 instances, the client's loss arose when the attorney accepted a retainer and then failed to perform services. Twelve claims were denied in 2016. In some instances, claims are denied when the facts do not substantiate the Claimant's version of events, but the most common reason for a denial is that the dispute does not fall within the Commission's jurisdiction, and instead is a fee dispute or simply a client's dissatisfaction with the results of a case.

In 2016, the Client Protection Fund Commission finished its eleventh full year of operation, paying

Joseph Conte Richard B. Spinello Since its inception, the rules for the Fund have included a cap on the maximum payment per claim in order to prevent a large loss from wiping out or impairing the Fund's ability to recompense other victims of dishonest attorney conduct. For 2016, the per-claim cap was increased from \$20,000 to \$50,000, in recognition of the Fund's health and our growing comfort that claims above \$20,000 are relatively rare in New Mexico. Only one claim in 2016 was affected by the increased cap, and this claim was actually a request for reconsideration of a claim previously approved, but capped at \$30,000. Be assured that even with the increased cap and high total payments in 2016 than prior years, the Fund remained strong, and even slightly increased its reserves.

I want to thank all my colleagues on the Commission for their service, and recognize Robert Valdez and Dustin Hunter who completed terms in 2016. Acknowledgment and appreciation is also due to the staff of the Disciplinary Board, William Slease, Anne Taylor, and Tamma Williams, who provide administrative support to the Commission; our ex-officio members from the State Bar, Richard Spinello and Joe Conte; and for the support of our Supreme Court liaison, Justice Edward L. Chavez.

INTRODUCTION



History and Purpose

The purpose of the Client Protection Fund (CPF) is to promote public confidence in the administration of justice and the integrity of the legal profession by reimbursing losses caused by the dishonest conduct of lawyers admitted and licensed to practice law in the courts of this jurisdiction. The Client Protection Fund Commission was established by order of the New Mexico Supreme Court effective Dec. 13, 2005, as a permanent commission of the State Bar of New Mexico Board of Bar Commissioners. The Supreme Court adopted a modified version of the American Bar Association's model rules for client protection funds and codified them at Rules 17A-001 *et seq.* of the New Mexico Rules Annotated. The Commission oversees the CPF and is charged with receiving, holding, managing, and disbursing money from the Fund according to the rules. The State Bar is responsible for administering the Commission, developing and approving the budget, and managing operations and staffing. Since January 1, 2014, the New Mexico Disciplinary Board has assisted in the technical administration of the Commission's tasks, including the processing of claims under the Commission's direction.



Revenues

The initial resources for the Fund were provided in 2005 by a Supreme Court order transferring funds from accumulated fines against lawyers who failed to comply with the Court's Minimum Continuing Legal Education requirements. In 2008 the Supreme Court ordered an additional transfer of funds from MCLE to the Fund. In 2009 the Supreme Court ordered a \$15 annual assessment of every active New Mexico attorney pursuant to Rule 17A-003 (B) NMRA. In 2010, 2012 and 2016 additional monies were also transferred from MCLE to the Fund by Supreme Court Orders. The State Bar provides in-kind support to the Fund and the Commission through staff support, office and meeting space, and fiscal administration. (See 2016 Financial Information, page 12). From time to time, the Fund receives monies from court-ordered sanctions directed to the fund at the discretion of the judge.



Eligible Claims

To qualify for a reimbursement from the Fund, a client must have incurred a financial loss caused by the dishonest conduct of a New Mexico-licensed lawyer who was counseling, advising, or representing the client or serving in another fiduciary capacity such as a trustee. The claim must be filed no later than five years after the client knew or should have known of the lawyer's dishonest conduct. Dishonest conduct is specifically defined under the CPF rules as wrongful acts such as theft or embezzlement of money or the wrongful taking or conversion of money, property, or other things of value; e.g., failing to refund unearned fees or borrowing money from a client without the intention to repay or disregarding the lawyer's inability or reasonably anticipated inability to repay. A typical CPF claim involves a lawyer who collected a retainer from a client, performed some legal work, and then became unable or unwilling to finish the work or refund the unearned amount.

The rules also include a hardship exception which allows the Commission, in cases of extreme hardship or special and unusual circumstances, to recognize a claim that was filed late or would not otherwise be reimbursable. This exception has only been used for one of the 229 claims approved in the Commission's eleven-year history. The maximum reimbursable amount was increased in 2012 from \$10,000 to \$20,000 per individual claim, and, effective January 1, 2016 from \$20,000 to \$50,000.



Processing a Claim

The claimant must complete a prescribed claim form and have it notarized. The claimant must provide a copy of any written agreement pertaining to the claim and copies of any checks, money orders, receipts, or other proof of payment. The claimant is responsible for completing the form and providing evidence of a reimbursable loss up to the maximum amount payable per claim.

The CPF gives notice of a claim to the lawyer against whom it is filed (or the lawyer's representative) and allows 20 days for a response. The Disciplinary Board is also notified of the claim. After the lawyer's response and other initial facts and documents are gathered, the claim is assigned to one of the CPF commissioners for investigation. The commissioner investigates and presents a recommendation to the full Commission. If appropriate under the circumstances, the recommendation includes the investigating commissioner's estimate of any amount that should be allowed as a credit against the claim for the value of work the lawyer performed or costs the lawyer properly paid with client funds. The approval or denial of a claim requires the affirmative votes of at least five commissioners.

The claimant and the lawyer are notified of the Commission's decision. Either party may request reconsideration in writing within 30 days of the denial or determination of the amount of a claim. If no request for reconsideration is received, the check for any approved reimbursement is sent after the notice period expires. If a timely request is received, the check for any approved reimbursement is sent after the Commission has reconsidered its decision. Rule 17A-013 NMRA provides that in either case the Commission's decision is final and there is no further right of appeal. Reimbursement is discretionary and no person has a legal right to reimbursement from the Fund. As part of the claim form, the claimant agrees to assign his/her claims against the lawyer to the fund in the event that the CPF makes a payment, and the CPF may pursue reimbursement and recovery from the lawyer or the lawyer's successor (e.g., an estate).

2016 ANNUAL REPORT HIGHLIGHTS AND COMMISSION ACTIVITIES

The Client Protection Fund Commission finished its eleventh full year of operation in 2016 paying \$157,916.76 in 22 claims against 15 lawyers. To date, the Commission has paid almost \$850,000 in cumulative reimbursements for clients' financial losses involving 58 lawyers. Year-by-year and cumulative statistics appear later in this report.

The Commission met 5 times in 2016, including at the State Bar of New Mexico Annual Meeting. Commissioners Frank Chavez and James Reist attended the 32st ABA National Forum on Client Protection in early June, 2016 in Philadelphia, Pennsylvania.

The State Bar's former Vice President Dustin K. Hunter left the Commission in June, 2016 when he was appointed to serve as a District Court Judge in the Fifth Judicial District. The Commission congratulates Judge Hunter on his appointment to the bench. The Commission will welcome his replacement for 2017, Gerald G. Dixon, the State Bar's Secretary-Treasurer.

As reported in the Commission's 2015 Annual Report, effective January 1, 2016, the limit that the Commission can pay to a claimant was increased by the New Mexico Supreme Court to \$50,000 per claim. As the Commission expected, this increase did not result in an unmanageable risk for the Commission nor deplete the Commission's ability to pay future, meritorious claims.

The Commission reminds everyone that Rule 17A-018(A) protects the confidentiality of information on claims, claimants, and respondent lawyers with exceptions for approved claims and other limited purposes as set forth below:

- A. Publicizing awarded claims. Claims, proceedings and reports involving claims for reimbursement are confidential until the commission authorizes reimbursement to the claimant, except as provided below, unless provided otherwise by law. After payment of the reimbursement, the commission shall publicize the nature of the claim, the amount of reimbursement, and the name of the lawyer. The name and the address of the claimant shall not be publicized by the commission unless specific permission has been granted by the claimant. The commission may provide a waiver to the claimant which authorizes disclosure.
- B. Exceptions. This rule shall not be construed to deny access to relevant information by the disciplinary board, other professional discipline agencies or other law enforcement authorities as the commission shall authorize, or the release of statistical information that does not disclose the identity of the lawyer or the parties, or the use of such information as is necessary to pursue the fund's subrogation rights under Rule 17A-015 NMRA.

2016 CLIENT PROTECTION FUND COMMISSION

From its inception in 2006 through 2012 the Commission consisted of seven lawyers—four appointed by the Supreme Court, two appointed by the Board of Bar Commissioners, and the vice president of the BBC. In 2013, the number of Commissioners was increased to nine. The 2016 commissioners and officers are listed here. All members except the BBC vice president serve staggered three-year terms. The BBC vice president serves for one year before advancing to become the State Bar president-elect and is succeeded on the Commission by the incoming vice-president. In 2016, the State Bar's then vice president was appointed to a judicial position and will be replaced on the Commission by the State Bar's secretary-treasurer. The six original commissioners were appointed for part of 2006 after the Commission was created and for staggered terms of one, two, and three years that began in 2007. Each of the six original commissioners has been appointed to two full three-year terms. The CPF officers, elected annually by the Commission, consist of a chair, vice-chair or treasurer, and secretary. Program assistance and administrative support is provided by the State Bar Office of General Counsel and the New Mexico Disciplinary Board.



Jason A. Marks, Chair Supreme Court Appointee

Jason Marks was appointed by the Supreme Court to a three-year term in one of the new positions approved effective for 2013, and was reappointed to the Commissioner for a term ending December 31, 2018. Marks is a sole practitioner in Albuquerque. His practice includes civil litigation, business advisory services, representation of public entities and utility law. Marks was elected and served two terms as a New Mexico Public Regulation Commissioner representing the Albuquerque area in 2005–2012. Prior to becoming an attorney, Marks led a national consulting practice in healthcare finance extending to 20 states and the federal government. Marks served as Commission Vice-Chair in 2014, and Chair for 2015 and 2016.



Frank N. Chavez, Treasurer State Bar of New Mexico Appointee

Frank attended New Mexico State University, University of Washington, and New Mexico Tech, obtaining degrees in Biology and Chemistry. Frank served in the US Army Reserve from 1964-1970. Before law school Frank worked for the New Mexico Dept. of Health as an environmentalist. Frank graduated from UNM School of law in 1969. After law school, Frank worked for the New Mexico Attorney General Office for 3 years, then became the City Attorney for las Cruces for 9 years. Thereafter Frank became a Partner and the President of Reeves, Chavez, Albers and Walker, the largest law firm in las Cruces from 1982 through 2004. Frank has been an AV rated attorney since 1995. Presently Frank conducts mediations, arbitrations, and serves on numerous boards. Frank's hobby is long distance bicycle riding.



Travis R. Steele, Secretary State Bar of New Mexico Appointee

Travis Steele was appointed by the BBC to one of the new positions approved by the Supreme Court effective Jan. 1, 2013. Steele practices primarily in the areas of commercial litigation, Indian gaming, oil and gas, and real estate litigation. He has conducted numerous hearings and trials in New Mexico state, federal and tribal courts. Steele regularly prosecutes and defends commercial lawsuits on behalf of his corporate clients, including contract disputes, lien issues, copyright claims, allegations of unfair business practices and any other issue that surfaces when business dealings fall apart. Steele regularly advises clients on licensure, regulatory and litigation matters related to Indian gaming and has substantial experience in sovereign immunity and tribal exhaustion cases. In addition, Steele has experience responding to federal investigations, including False Claims Act investigations by the Office of the Inspector General. He practices in civil and corporate matters, including family law, bankruptcy, and personal injury. He provides pro bono services through partnership with New Mexico Legal Aid by conducting legal aid and pro se divorce clinics. He is a 2011 recipient of the *Albuquerque Business First* 40 Under Forty award. He is co-chair of the Chaves County Pro Bono Committee and president of the Chaves County Bar Association. Richard B. Spinello

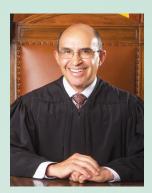
Administrator and Staff Counsel, General Counsel, State Bar of New Mexico

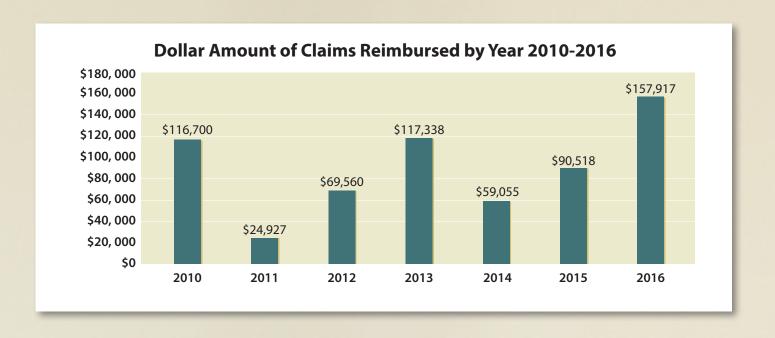

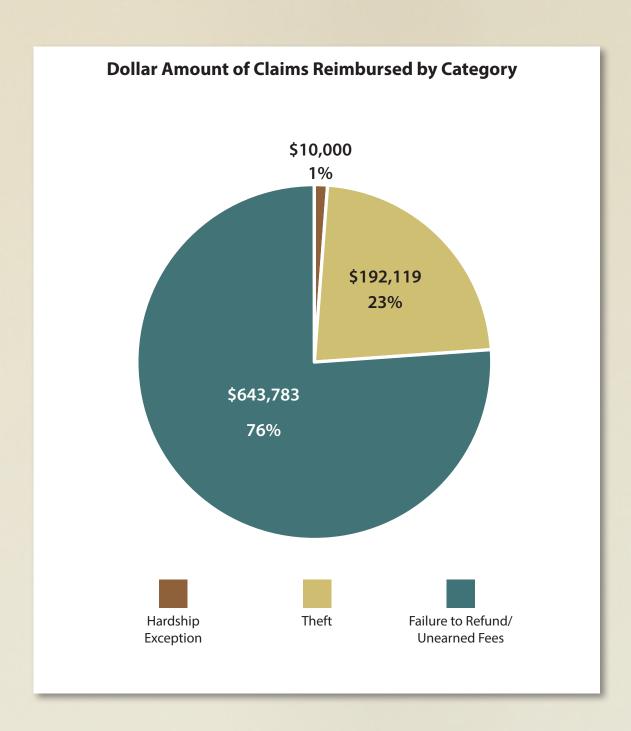

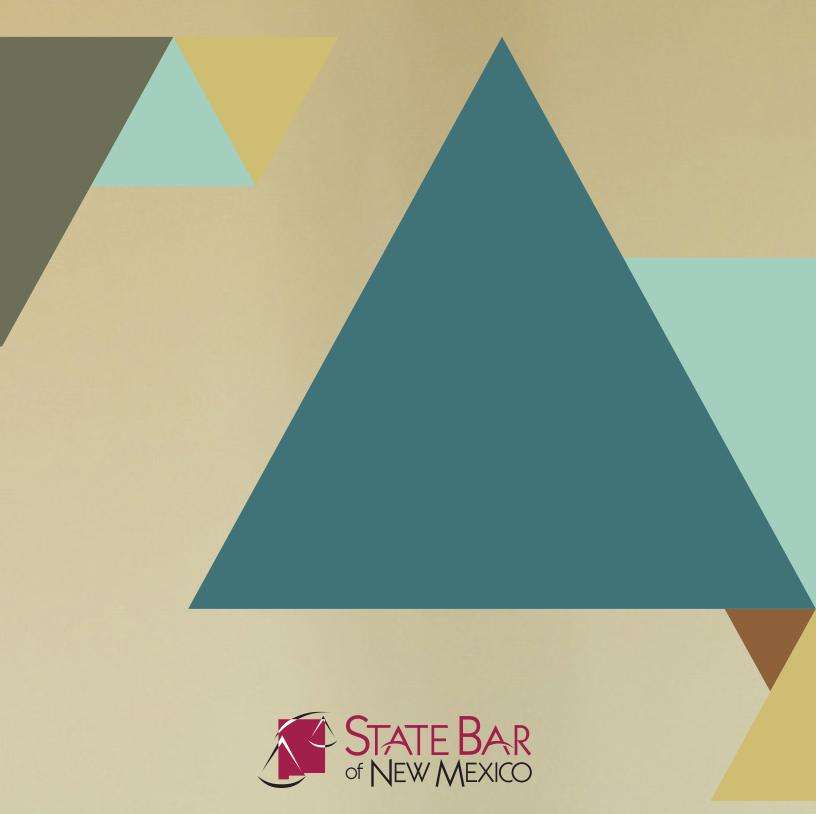
